Public notice was given for this solicitation, CLMC683A Govalle Neighborhood Park Pool Renovation REBID, through the City's Vendor Connection web portal. Two bids were received and opened on May 10, 2018. Of the two bids received none of the firms submitting were certified MBE/WBE. HB Construction submitted the lowest responsive bid of two bids including an alternate of \$37,950 and an allowance of \$70,000:
