Authorize negotiation and execution of a multi-term contract with Waste Repurposing International Inc., to provide recycling of alkyds and solvents, for up to five years for a total contract amount not to exceed \$355,000. (Note: This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program. For the services required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established).

Additional Backup Information:

The contract is for the recycling of alkyds and solvents needed to accommodate the new alkyds program. Alkyds and solvents can include common items such as oil-based paints, paint thinners, stains, and polyurethanes. The program allows residential customers of Austin Resource Recovery (ARR) and City municipal departments to easily and safely discard their unwanted alkyds in order for them to be reused or recycled at the Recycle and Reuse Drop-off Center's Household Hazardous Waste Facility (HHW). The HHW facility currently has a diversion rate of 48% of all materials received. In Fiscal Year 2015-2016, the City collected 272,000 pounds of alkyds and solvents. It is ARR's estimation that approximately 60% of the alkyds and solvents the City receives are recyclable or reusable. This contract will allow the increase in diversion of these alkyds and solvents and help the City get closer to the City's zero waste goals.

An evaluation team with expertise in this area evaluated the offers and scored Waste Repurposing International Inc. as the best to provide these services based on system concept and solutions proposed, cost, demonstrated applicable experience, facility plans, local business presence and service disabled veteran business enterprise certification.

This request allows for the development of a contract with a qualified offeror selected by Council. If the City is unsuccessful in negotiating a satisfactory contract with the selected offeror, negotiations will cease with that provider.

This is a new contract. The requested authorization amount was determined using departmental estimates based on annual amounts of alkyds and solvents being received at the HHW facility and allows for a small annual increase to account for an anticipated increase in material received.
