4 **WHEREAS**, Legacy Ranch @ Dessau East, LP (“Applicant”), its successors, assigns
5 or affiliates, proposes to construct an affordable multi-family rental housing development
6 with approximately 232 units that is located near the intersection of Dessau Road and Fish
7 Lane (“Development”) in the City of Austin; and

8 **WHEREAS**, Applicant, its successors, assigns or affiliates, has advised that it intends
9 to submit an application to the Texas Department of Housing and Community Affairs for
0 4% Low Income Housing Tax Credits for the Development to be known as Legacy Ranch
1 @ Dessau East Apartments; **NOW, THEREFORE,**

2 ||| **BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

3 In accordance with Section 2306.67071 of the Texas Government Code, the City
4 Council finds that:

1. the Applicant provided notice to the City Council as required by Subsection (a); and
2. the City Council had sufficient opportunity to obtain a response from the Applicant regarding any questions or concerns about the proposed Development; and
3. the City Council held a hearing at which public comment could be made on the proposed Development as required by Subsection (b); and
4. after due consideration of the information provided by the Applicant and public comment, the City Council does not object to the Applicant's proposed application to the Texas Department of Housing and Community Affairs; and

23 **BE IT FURTHER RESOLVED:**

24 Pursuant to Section 2306.6703(a)(4) of the Texas Government Code and Sections 11.3
25 and 11.4 of Texas' Qualified Allocation Plan, the City Council supports the proposed
26 Development; affirms that the proposed Development is consistent with the jurisdiction's
27 obligation to affirmatively further fair housing; approves the construction and rehabilitation
28 of the proposed Development; and authorizes an allocation of Housing Tax Credits for the
29 proposed Development; and

30 **BE IT FURTHER RESOLVED:**

31 Pursuant to Section 11.3 of Texas' Qualified Allocation Plan, the City Council
32 expressly acknowledges and confirms that the City has more than twice the state average of
33 units per capita supported by Housing Tax Credits or Private Activity Bonds; and

34 **BE IT FURTHER RESOLVED:**

35 The City Council authorizes, empowers, and directs Jannette S. Goodall, City Clerk, to
36 certify this resolution to the Texas Department of Housing and Community Affairs.
