**RESOLUTION NO.**

5       **WHEREAS**, On August 23, 2018, Council adopted Resolution No.  
6       20180823-078, which in part, directed the City Manager to identify all remaining  
7       properties currently being used as mobile home residence park or mobile home  
8       subdivision, but not zoned mobile home residence (MH) district and submit the  
9       properties to Council for initiation of the appropriate zoning cases; and

10       **WHEREAS**, staff identified 20 remaining properties meeting the description  
11       in Resolution No. 20180823-078;

12       **NOW, THEREFORE,**

13       **BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

14       The City Council initiates the zoning, rezoning, and where appropriate, future  
15       land use map (FLUM) amendments for the following properties:

18       combining district to mobile home residence-neighborhood plan (MH-NP)

21       Southbound, Austin, Texas, from general commercial services-neighborhood plan  
22       (CS-NP) combining district to mobile home residence-neighborhood plan (MH-NP)

24       (3) Go-Go MH Park located at 4811 South Congress Avenue, Austin, Texas,  
25       from general commercial services-mixed use-conditional overlay-neighborhood

4 general commercial services-mixed use-vertical mixed use building-conditional

7 (5) Aero Mobile Home Park located at 101 Hergotz Lane, Austin, Texas,  
8 from family residence (SF-3) district to mobile home residence (MH) district;

9 (6) Tejas Mobile Plaza located at 1709 East State Highway 71 Westbound,  
10 Austin, Texas, from community commercial (GR) district and neighborhood  
11 commercial (LR) district to mobile home residence (MH) district;

12 (7) Templeton MH Park located at 401 Chaparral Road, Austin, Texas, from  
13 single-family residence standard lot (SF-2) district to mobile home residence (MH)  
14 district;

15 (8) Villa Denese located at 4511 Lucksinger Lane, Austin, Texas, from  
16 general commercial services-mixed use-conditional overlay-neighborhood plan  
17 (CS-MU-CO-NP) combining district to mobile home residence-neighborhood plan  
18 (MH-NP) combining district;

19 (9) Mobile Home Haven located at 11606 North Lamar Boulevard, Austin,  
20 Texas from public (P) district to mobile home residence (MH) district;

21 (10) Congress MH/RV Park located at 6111 South Congress Avenue, Austin,  
22 Texas from community commercial-mixed use-conditional overlay-neighborhood  
23 plan (GR-MU-CO-NP) combining district to mobile home residence-neighborhood  
24 plan (MH-NP) combining district;

1 (11) Jensen's MH Park located at 3201 Burleson Road, Austin, Texas from  
2 family residence-neighborhood plan (SF-3-NP) combining district to mobile home  
3 residence-neighborhood plan (MH-NP) combining district;

4 (12) Little Texas MHC located at 7501 Bluff Springs Road, Austin, Texas,  
5 from interim-rural residence (I-RR) district to mobile home residence (MH) district;

6 (13) Woodview MHC, LLC located at 1301 West Oltorf Street, Austin,  
7 Texas, from general commercial services (CS) district to mobile home residence  
8 (MH) district;

9 (14) Cameron Loop Mobile HP located at 2807 Cameron Loop, Austin,  
10 Texas, from rural residence (RR) district to mobile home residence (MH) district;

11 (15) Capitol Manor Mobile Home Park, LLC located at 1308 Thornberry  
12 Road, Austin, Texas, from interim-rural residence (I-RR) district to mobile home  
13 residence (MH) district;

14 (16) Patton Courts Mobile Home Park located at 7100 East US Highway 290,  
15 Austin, Texas, from general commercial services-neighborhood plan (CS-NP)  
16 combining district, general commercial services-mixed use-neighborhood plan (CS-  
17 MU-NP) combining district, and townhouse and condominium residence (SF-6)  
18 district to mobile home residence-neighborhood plan (MH-NP) combining district;

19 (17) Lee Hill Park located at 8001 Lee Hill Drive, Austin, Texas from  
20 warehouse limited office-neighborhood plan (W/LO-NP) combining district and  
21 general commercial services-conditional overlay-neighborhood plan (CS-CO-NP)  
22 combining district to mobile home residence-neighborhood plan (MH-NP)  
23 combining district;

1 (18) Wallace Trailer Park located at 423 Thompson Lane, Austin, Texas,  
2 from general commercial services-conditional overlay (CS-CO) combining district  
3 to mobile home residence (MH) district;

4 (19) Austin Pecan Park located at 2815 East State Highway 71 Westbound  
5 Service Road, Austin, Texas, from rural residence (RR) district, interim single-  
6 family residence standard lot (I-SF-2) district, and development reserve (DR) district  
7 to mobile home residence (MH) district;

8 (20) Honeycomb Park located at 6402 McNeil Drive, Austin, Texas, from  
9 interim-rural residence (I-RR) district to mobile home residence (MH) district.

10 **BE IT FURTHER RESOLVED:**

11 The City Council initiates City Code Title 25 amendments, as necessary, to  
12 implement the zoning changes.
