M/WBE Summary

Participation subgoals stated in the solicitation were 1.90% African American; 9.00% Hispanic; 4.90% Asian/Native Asian; and 15.80% WBE. The recommended firms provided a MBE/WBE Compliance Plan that met the goals of the solicitation and were approved by the Small and Minority Business Resources Department.

Public notice was given for this solicitation (CLMP246 South Area and Northwest Area Lift Station Improvements), through the City's Vendor Connection web portal. Sixteen firms submitted qualifications statements and submittals were opened on July 7, 2018. Of the sixteen submittals received, one submittal was from an MBE/WBE certified firm. Of the 16 firms evaluated, 6 were short-listed and interviewed which resulted in the following recommendation:
