The City Council Questions and Answers Report was derived from a need to provide City Council Members an opportunity to solicit clarifying information from City Departments as it relates to requests for council action. After a City Council Regular Meeting agenda has been published, Council Members will have the opportunity to ask questions of departments via the City Manager's Agenda Office. This process continues until 5:00 p.m. the Tuesday before the Council meeting. The final report is distributed at noon to City Council the Wednesday before the council meeting.

QUESTIONS FROM COUNCIL

20. Agenda Item #20: Approve an ordinance amending the Fiscal Year 2018-2019 Schedule of Fees, Fines, and Other Charges to be set or charged by the City (Ordinance No. 20180911-002) to revise the Parks and Recreation Department's Cemetery Operations fees to fund increased contract fees from the vendor for interment services.

QUESTION:

What factors were included in revising the fee schedule? Please share any market study analyses conducted to determine the new fee structure.

COUNCIL MEMBER FLANNIGAN'S OFFICE

ANSWER:

The revised fee schedule is the result of a request from the vendors who asked for a price increase in order to accommodate increased costs of living expenses, as well as equipment leases. PARD cemetery staff utilized the 2016 market research document published by the Funeral Consumer Alliance of Central Texas as backup for their research associated with fees.

26. Agenda Item #26: Authorize negotiation and execution of an interlocal agreement with the Health and Human Services Commission for the Community Partner Program for a 48-month term.

QUESTION: Will this interlocal agreement require staff bandwidth or any other resources? Is

HHSC reimbursing APH for these? If not, are resources already included in the approved budget? COUNCIL MEMBER ALTER'S OFFICE

ANSWER:

This interlocal agreement allows existing Neighborhood Services Unit (NSU) staff to assist clients apply for Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF), Children's Health Insurance Program (CHIP) and Health and Human Services Commission (HHSC) programs. The Community Services Block Grant (CSBG) is the one of the major funding sources for NSU. One of the requirements of the grant is to connect clients to community resources by completing applications for services. While HHSC does not provide reimbursement, the agreement allows staff access to connect our clients directly to SNAP, TANF and CHIP. Funding was approved in the FY 19 budget for CSBG grant funding and general funds for existing employees to provide these services.

30. Agenda Item #30: Authorize negotiation and execution of a multi-term contract with Contract Callers, Inc., or one of the other qualified offerors to Request For Proposals 1100 SMB3001, to provide tertiary level collection services on delinquent utility accounts, for up to five years for a total contract amount not to exceed \$2,500,000.

QUESTION:

- Can you please provide more descriptive data about the accounts sent to collections, both secondary and tertiary, to include overall number of accounts, overall dollar amount, average number of accounts sent per month, average dollar amount of accounts, and recovery rates? Please also provide any descriptive statistics available about the types of accounts, whether any customer assistance programs had been used to bring the accounts current before or after the accounts were sent to collections, and service locations (by ZIP code, Council District, or other aggregated measure), if possible.
- 2. Section IV (B) of the scope of work included in the solicitation documents states that AE can recall accounts from secondary and tertiary collections at its discretion. What factors are considered when making a determination to recall an account from collections?
- 3. When reviewing and scoring proposals, is any consideration given to complaints against the respondents filed with the Consumer Financial Protection Bureau or other agencies for unfair collections practices?

COUNCIL MEMBER GARZA'S OFFICE

ANSWER:

Accounts placed with a secondary level collection company are for customer accounts
that have been inactive for 1-2 years or for customers who left the service area with debt
owed. Accounts placed with tertiary collection agencies are for accounts that have been
inactive at least two years or for customers who left the service area with debt owed.

Due to the short turn around on this request, staff was unable to gather the district and zip code data because the debt is 3-15 years old and may span two billing systems, and the debt is for the last physical address at which the customer resided.

The City of Austin Utilities has numerous resources and programs to help customers pay bills and keep balances current. In addition, the City (internally) attempts to collect any outstanding balances for 30-45 days prior to sending to a primary collection services agency.

- 2. The City of Austin will recall accounts from the third party collection service companies for the following reasons: adjustments made to the customer's final bill, the customer moves back into the service area and agrees to pay the past due balance to start new services, or the customer notifies us of a bankruptcy filing or identity theft case.
- 3. Yes. In the solicitation, respondents were asked to describe how they tested for Fair Debt Collection Practices Act (FDCPA) compliance; and if their agency has been fined, censured or reprimanded for failure to comply with the FDCPA or other state collection regulations, to explain the circumstances involved. During the previous contract from June 2016 to May 2018, the City of Austin Utilities did not receive any escalations involving the way Contract Callers, Inc. handled collecting customer debt.

QUESTION:

Please explain why there is a reduction in scope, but an increase in contractual costs? Has the contractor been in compliance with the current contract? If no, what remedies have been achieved to bring the contractor into compliance?

Please share all amendments to the contract with Internment Services, Inc.

COUNCIL MEMBER FLANNIGAN'S OFFICE

ANSWER:

- 1. The price increase, as requested by the Contractor, is necessary in order to extend the current contract. The City has already tried to re-solicit for these services, receiving no offers, including none from the current contractor. As the City intends to begin performing these services using internal staff in the coming years, there is little to no interest in the market to provide these services on a short-term basis. Even under the reduced scope, the current contractor is only willing to continue to perform these services at a higher rate. Given the City's short-term plans to discontinue contracting for these services and the lack of interest from the market to perform these services on an interim basis, staff recommends approval of this item
- 2. The Contractor is in compliance with the terms of the contract. Over the contract's

term thus far, there have been a few performance issues. Each time, when the issue was brought to the contractor's attention, the contractor took appropriate action to resolve the issue. Examples of performance issues that were successfully resolved under this contract include resetting of monuments and correcting any damage to monuments as requested by the City.

3. Attached are copies of the executed contract amendment numbers 1 and 2 as well as the proposed contract amendment number 3, which is subject to Council authorization.

QUESTION: The primary purpose of a train horn is to warn persons and animals of danger from a passing train, especially near grade crossings, in order to prevent accidents. Please provide specifics regarding planned measures to mitigate risks (such as: improved gates that block traffic in all directions, road channelization or medians that prevent cars from driving around gates, converting two-way streets into one-ways or prohibiting cars from crossing the tracks at night, wayside horns which sound at the crossing, not on the trains, limiting noise pollution, as relevant). Please explain what was considered and why a specific measure was chosen. COUNCIL MEMBER ALTER'S OFFICE

ANSWER (REVISED):

The purpose of railroad train horns is to warn persons or animals who may be in the way of an oncoming train of approaching danger. Establishment of a railroad quiet zone requires implementation of design features that limits the need for the train engineer to sound a warning horn. Establishment of a quiet zone does not eliminate the responsibility of the train engineer to sound the horn anytime a safety threat is observed. Thus, even with a quiet zone, if a person wanders too close to the track, an approaching train engineer is required to sound the horn. A quiet zone does limit the opportunity for people, animals, and cars to intrude into the operating space of the railroad, therefore limiting the likelihood on a routine basis for the trains to sound their horns. The quiet zone does not address other noise generated by the railroad such as Diesel engine noise, mechanical noise, or rail squeal.

Working with the Union Pacific Railroad (UPRR), Austin has successfully established quiet zones throughout the community along the MoPAC UPRR rail line. The subject crossing located at Paul and Pressler streets is the last remaining non-quiet zone in central Austin. The agreement with UPRR authorizes the railroad to develop the design of the proposed quiet zone and in coordination with the City, implement the modifications. The existing unprotected rail crossings at both Pressler and Paul Streets will be brought up to safe quiet zone standards, likely

requiring a full quad gate, with the actual design elements to be developed by UPRR in coordination with the City of Austin as part of the proposed funding. Safe at-grade pedestrian crossings of the UPRR track will be included as part of the project.

COUNCIL MEMBER ALTER'S OFFICE

ANSWER:

The Economic Development Department (EDD) has not participated in the Greater Austin San-Antonio Corridor Council. The Austin Transportation Department will work with EDD to identify opportunities to participate in the future.

Fire and EMS are planning to locate the Canyon Creek station at the City property located on 620. This future station will meet the 'Standard of Coverage' response time goal for arrival in eight (8) minutes or less 90% of the time. Austin Police requested a delay in discussing/evaluating co-location of a North West APD Substation until December 2018.

Further, this will be addressed by staff in early 2019 as part of NHCD's strategy to implement the Housing Blueprint and deploy the 2018 General Obligation Bonds for Affordable Housing.





QUESTION:

- 1. Can you please provide more descriptive data about the accounts sent to collections, both secondary and tertiary, to include overall number of accounts, overall dollar amount, average number of accounts sent per month, average dollar amount of accounts, and recovery rates? Please also provide any descriptive statistics available about the types of accounts, whether any customer assistance programs had been used to bring the accounts current before or after the accounts were sent to collections, and service locations (by ZIP code, Council District, or other aggregated measure), if possible.
- 2. Section IV (B) of the scope of work included in the solicitation documents states that AE can recall accounts from secondary and tertiary collections at its discretion. What factors are considered when making a determination to recall an account from collections?
- 3. When reviewing and scoring proposals, is any consideration given to complaints against the respondents filed with the Consumer Financial Protection Bureau or other agencies for unfair collections practices?

COUNCIL MEMBER GARZA'S OFFICE

ANSWER:

1. Accounts placed with a secondary level collection company are for customer accounts that have been inactive for 1-2 years or for customers who left the service area with debt owed. Accounts placed with tertiary collection agencies are for accounts that have been inactive at least two years or for customers who left the service area with debt owed.

Due to the short turn around on this request, staff was unable to gather the district and zip code data because the debt is 3-15 years old and may span two billing systems, and the debt is for the last physical address at which the customer resided.

The City of Austin Utilities has numerous resources and programs to help customers pay bills and keep balances current. In addition, the City (internally) attempts to collect any outstanding balances for 30-45 days prior to sending to a primary collection services agency.

- 2. The City of Austin will recall accounts from the third party collection service companies for the following reasons: adjustments made to the customer's final bill, the customer moves back into the service area and agrees to pay the past due balance to start new services, or the customer notifies us of a bankruptcy filing or identity theft case.
- 3. Yes. In the solicitation, respondents were asked to describe how they tested for Fair Debt Collection Practices Act (FDCPA) compliance; and if their agency has been fined, censured or reprimanded for failure to comply with the FDCPA or other state collection regulations, to explain the circumstances involved. During the previous contract from June 2016 to May 2018, the City of Austin Utilities did not receive any escalations involving the way Contract Callers, Inc. handled collecting customer debt.

COUNCIL MEMBER FLANNIGAN'S OFFICE

ANSWER:

- 1. The price increase, as requested by the Contractor, is necessary in order to extend the current contract. The City has already tried to re-solicit for these services, receiving no offers, including none from the current contractor. As the City intends to begin performing these services using internal staff in the coming years, there is little to no interest in the market to provide these services on a short-term basis. Even under the reduced scope, the current contractor is only willing to continue to perform these services at a higher rate. Given the City's short-term plans to discontinue contracting for these services and the lack of interest from the market to perform these services on an interim basis, staff recommends approval of this item
- 2. The Contractor is in compliance with the terms of the contract. Over the contract's term thus far, there have been a few performance issues. Each time, when the issue was brought to the contractor's attention, the contractor took appropriate action to resolve the issue. Examples of performance issues that were successfully resolved under this contract include resetting of monuments and correcting any damage to monuments as requested by the City.
- 3. Attached are copies of the executed contract amendment numbers 1 and 2 as well as the proposed contract amendment number 3, which is subject to Council authorization.

- 1.0 The City hereby exercises the extension option for the above-referenced Contract. Effective November 29, 2018, the term for the extension option will be November 29, 2018 to November 28, 2021. The City reserves the right to extend the Contract for the remaining two years of the original five-year extension option.
- 2.0 Effective November 29, 2018, through the Contract expiration or termination, the Contract is hereby amended as follows.
 - 2.1 Paragraph 4.5 of the Contract is replaced in its entirety with the following:
 - 4.5 **Termination Without Cause**. The City shall have the right to terminate the Contract, in whole or in part without cause any time prior to November 28, 2021 with 365 calendar days prior written notice to the Contractor. The Contractor shall have the right to terminate the Contract, in whole or in part without cause any time with 30 calendar days prior written notice to the City. Upon receipt of a notice of termination from the City, the Contractor shall promptly cease all further work pursuant to the Contract, with such exceptions, if any, specified in the notice of termination. The City shall pay the Contractor, to the extent of funds Appropriated or otherwise legally available for such purposes, for all goods delivered and services performed and material and supply obligations incurred prior to the date of termination for the sole purpose of this Contract and as negotiated between the Contractor and the City.
 - 2.2 Paragraph 2.2.9 of the Contract is replaced in its entirety with the following:
 - 2.2.9 **Equipment**. Contractor shall acquire and own all equipment and portable structures necessary for the performance of work under this Contract SOW. Contractor shall be responsible for the maintenance, cleaning, and replacement of equipment. The City grants the Contractor the right to store equipment necessary for the performance of its contract obligations on City cemetery property as approved by the Cemetery Manager. Storage shall not exceed the space authorized by the City. Contractor and Contractor's employees shall park privately owned vehicles in designated parking places as determined by the City. The City is not responsible for any damage or loss to Contractor's equipment, tools and supplies stored or staged on City premises.
 - 2.3 Paragraph 2.2.8.is replaced in its entirety with the following:
 - 2.2.8 Monument Setting. The Contractor shall provide monument setting services for monuments temporarily moved for adjacent interment/disinterment services provided by the Contractor. Any adjacent monuments temporarily moved to facilitate an interment must be replaced within 24 hours after the burial. If unforeseen circumstances require more time, the Contractor shall provide to the City's Contract Manager for approval, a plan and time frame for replacement.
 - 2.4 The following Paragraph 2.1.1 is added to the Contract.

- 2.1.1 To the full extent allowed by law, the Contractor has the exclusive right to perform all burials and interments at City-owned cemeteries for the extension period beginning on November 29, 2018 and ending on November 28, 2021, or upon termination earlier than November 28, 2021.
- 2.5 Paragraph 7.23.7 is replaced in its entirety with the following:
 - 7.23.7 Contractor shall submit employee certifications annually with the respective invoice to verify that employees are paid the Living Wage throughout the term of the Contract.
- 3.0 The Contract's Exhibit B Fee Schedule is hereby replaced in its entirety with the attached "Exhibit B Fee Schedule effective November 29, 2018". The prices represented in the updated Exhibit B shall remain firm for the three-year extension period.
- 4.0 The total Contract amount is increased by \$2,843,500.00 for the extension option period. The total Contract authorization is recapped below:

QUESTION: The primary purpose of a train horn is to warn persons and animals of danger from a passing train, especially near grade crossings, in order to prevent accidents. Please provide specifics regarding planned measures to mitigate risks (such as: improved gates that block traffic in all directions, road channelization or medians that prevent cars from driving around gates, converting two-way streets into one-ways or prohibiting cars from crossing the tracks at night, wayside horns which sound at the crossing, not on the trains, limiting noise pollution, as relevant). Please explain what was considered and why a specific measure was chosen.


ANSWER (REVISED):

COUNCIL MEMBER ALTER'S OFFICE

The purpose of railroad train horns is to warn persons or animals who may be in the way of an oncoming train of approaching danger. Establishment of a railroad quiet zone requires implementation of design features that limits the need for the train engineer to sound a warning horn. Establishment of a quiet zone does not eliminate the responsibility of the train engineer to sound the horn anytime a safety threat is observed. Thus, even with a quiet zone, if a person wanders too close to the track, an approaching train engineer is required to sound the horn. A quiet zone does limit the opportunity for people, animals, and cars to intrude into the operating space of the railroad, therefore limiting the likelihood on a routine basis for the trains to sound their horns. The quiet zone does not address other noise generated by the railroad such as Diesel engine noise, mechanical noise, or rail squeal.

Working with the Union Pacific Railroad (UPRR), Austin has successfully established quiet zones throughout the community along the MoPAC UPRR rail line. The subject crossing located at Paul and Pressler streets is the last remaining non-quiet zone in central Austin. The agreement with UPRR authorizes the railroad to develop the design of the proposed quiet zone and in coordination with the City, implement the modifications. The existing unprotected rail crossings at both Pressler and Paul Streets will be brought up to safe quiet zone standards, likely requiring a full quad gate, with the actual design elements to be developed by UPRR in coordination with the City of Austin as part of the proposed funding. Safe at-grade pedestrian crossings of the UPRR track will be included as part of the project.



MAYOR PRO TEM KATHIE TOVO'S OFFICE

ANSWER:

As this project was awarded Development Assistance funds through the Rental Housing Development Assistance program, this property is required to comply with the tenant protections program as referenced in Resolution No. 20180510-051. The process for incorporating these protections into all bond issuances has been identified and will be initiated for future bond issuances. Staff is preparing a response to submit prior to the timeline set in the Resolution. Further, this will be addressed by staff in early 2019 as part of NHCD's strategy to implement the Housing Blueprint and deploy the 2018 General Obligation Bonds for Affordable Housing.
