Additional Backup Information:

On February 21, 2019, Texas Gas Service (TGS), a division of ONE Gas, Inc., notified the City of its intent to begin collecting of Pipeline Integrity Testing (PIT) expenses in the amount of \$758,590 incurred in the Central Texas Service Area (CTSA) during the calendar year ending December 31, 2018. Cost recovery of the PIT expenses will be via a surcharge on customer bills beginning with the April 2019 billing cycle and continuing through March 2020. Other cities in the CTSA include Bee Caves, Cedar Park, Cuero, Dripping Springs, Gonzales, Kyle, Lakeway, Lockhart, Luling, Nixon, Rollingwood, Shiner, Sunset Valley, West Lake Hills, and Yoakum, Texas. The PIT Rider that authorizes the surcharge requires that initial notice to customers of the PIT surcharge be filed with, reviewed, and approved by the City, which is the regulatory authority for City of Austin customers.

The effect of the PIT surcharge will affect the various customer classes in the CTSA as follows:
