Thirty two firms submitted qualifications statements and responses were opened on December 6, 2018. Of the thirty two submittals received three submittals were from MBE/WBE certified firms.

Participation subgoals stated in the solicitation were 1.90 % African American; 9.00% Hispanic; 4.90% Native Asian; 15.80% WBE. The recommended firms provided a MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.
