5 **AN ORDINANCE AUTHORIZING NEGOTIATION AND EXECUTION OF AN**  
6 **ADVANCE FUNDING AGREEMENT WITH THE TEXAS DEPARTMENT OF**  
7 **TRANSPORTATION; ACCEPTING GRANT FUNDS; AND AMENDING THE**  
8 **FISCAL YEAR 2018-2019 AUSTIN TRANSPORTATION DEPARTMENT**  
9 **OPERATING BUDGET SPECIAL REVENUE FUND (ORDINANCE NO.**  
10 **20180911-001) AND THE FISCAL YEAR 2018-2019 AUSTIN**  
11 **TRANSPORTATION DEPARTMENT CAPITAL BUDGET (ORDINANCE NO.**  
12 **20180911-001) TO TRANSFER AND APPROPRIATE AND TRANSFER GRANT**  
13 **FUNDS.**

15 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

17 **PART 1.** Council authorizes the negotiation and execution of an Advance Funding  
18 Agreement with the Texas Department of Transportation (TxDOT) for the design and  
19 installation additional traffic monitoring cameras and a video management system.

20 **PART 2.** Council authorizes the acceptance of \$1,120,000 in grant funds from TxDOT  
21 for the design and installation of additional traffic monitoring cameras and a video  
22 management system.

23 **PART 3.** Council amends the Fiscal Year 2018-2019 Austin Transportation Department  
24 Operating Budget Special Revenue Fund (Ordinance No. 20180911-001) to accept and  
25 appropriate \$1,120,000 in grant funds for the design and installation of additional traffic  
26 monitoring cameras and a video management system.

27 **PART 4.** Council amends the Fiscal Year 2018-2019 Austin Transportation Department  
28 Capital Budget (Ordinance No. 20180911-001) to transfer in and appropriate \$1,120,000  
29 from the Austin Transportation Department Operating Budget Special Revenue Fund for  
30 the design and installation additional traffic monitoring cameras and a video management  
31 system.
