# Posting Language

Authorize negotiation and execution of a multi-term cooperative contract with Sirius Computer Solutions, Inc., to provide software services, for up to three years in an amount not to exceed \$300,000.

The contract is for Recorded Future software products and services including maintenance support and training for Austin Energy. Recorded Future software will be used to augment Austin Energy's information security program.

Cooperative agreements save taxpayer dollars by leveraging the State's volume-buying power to drive down
