3	WHEREAS, the City Council seeks to ensure that Downtown Austin
4	continues to appeal to residents and visitors alike; and
5	WHEREAS, the 2009 Downtown Design Guidelines recommended creating
6	drinking fountains throughout the urban landscape; and
7	WHEREAS, City Code requires that drinking fountains be included as part
8	of the design of certain public facilities, including municipal pools; and
9	WHEREAS, the 2016 Age Friendly Action Plan recommends increasing the
10	number of public spaces equipped with drinking fountains as one strategy for
11	increasing access to open spaces and public buildings; and
12	WHEREAS, Council has received testimony in recent years urging the City
13	of Austin to install drinking fountains in Downtown; and
14	WHEREAS, in 2018, Austin experienced 51 days with temperatures 100
15	degrees or higher, and 42 such days in 2017; and
16	WHEREAS, climate change is causing temperatures to rise, and 2018 was
17	Austin's third-hottest summer of record; and
18	WHEREAS, access to free fresh water, particularly during the warm
19	summer months, is vital to life and health; and
20	WHEREAS, drinking fountains in our growing Downtown would serve a
21	variety of diverse users, including visitors, Downtown employees and patrons,
22	individuals experiencing homelessness, and individuals using bicycle and
23	pedestrian infrastructure; and

24	WHEREAS, many cities of all sizes have recognized the importance of free
25	drinking fountains and have invested in this infrastructure; NOW, THEREFORE,
26	BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:
27	The City Manager is directed to consult with the relevant City departments,
28	the Downtown Austin Alliance, and other interested stakeholders to identify at
29	least 10 locations within the boundaries of I-35, 15th Street, Lady Bird Lake, and
30	Lamar Boulevard, that would be suitable to install free, ADA complaint, 24-hour
31	drinking fountains. At least two of these proposed locations should be in the area
32	bounded by Red River Street, E. 8th Street, Trinity Street, and E. 7th Street and one
33	in the area near E. 4th Street, in the general vicinity of the Downtown Metro Rail
34	Station and the Convention Center.
35	The City Manager is directed to bring forth both the proposed locations and
36	a budget estimate for the installation, operations, and maintenance of drinking
37	fountains no later than September 1, 2019, so Council may consider a budget
38	allocation during the Fiscal Year (FY) 2019-2020 budget adoption process. The
39	City Manager is directed to analyze whether these costs could be borne by the
40	Austin Water Utility.
41	BE IT FURTHER RESOLVED:
42	Should a FY 19-20 budget allocation be successful, the City Manager is
43	directed to expedite the procurement process so drinking fountains can be installed
44	and functional as quickly as possible.
