6 **AN ORDINANCE AUTHORIZING AN INTERLOCAL AGREEMENT WITH**  
7 **CAPITAL METROPOLITAN TRANSPORTATION AUTHORITY; ACCEPTING**  
8 **GRANT FUNDS; AND AMENDING THE FISCAL YEAR 2019-2020 AUSTIN**  
9 **TRANSPORTATION DEPARTMENT OPERATING BUDGET SPECIAL**  
10 **REVENUE FUND (ORDINANCE NO. 20190910-001) AND THE FISCAL YEAR**  
11 **2019-2020 AUSTIN TRANSPORTATION DEPARTMENT CAPITAL BUDGET**  
12 **(ORDINANCE NO. 20190910-001) TO TRANSFER AND APPROPRIATE FUNDS.**

14 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

16 **PART 1.** The Council authorizes the City to negotiate and execute an interlocal  
17 agreement with Capital Metropolitan Transportation Authority (CMTA) for their share of  
18 matching funds for Smart Trips Austin to assist residents who recently relocated to or  
19 within Austin find transportation solutions.

20 **PART 2.** The Council authorizes the acceptance of up to \$22,500 in funds from CMTA  
21 for Smart Trips Austin to assist residents who recently relocated to or within Austin find  
22 transportation solutions.

23 **PART 3.** The Council amends the Fiscal Year 2019-2020 Austin Transportation  
24 Department Operating Budget Special Revenue Fund (Ordinance No. 20190910-001) to  
25 appropriate up to \$22,500 in funds for Smart Trips Austin to assist residents who recently  
26 relocated to or within Austin find transportation solutions.

27 **PART 4.** The Council amends the Fiscal Year 2019-2020 Austin Transportation  
28 Department Capital Budget (Ordinance No. 20190910-001) to transfer in and appropriate  
29 up to \$22,500 from the Austin Transportation Department Operating Budget Special  
30 Revenue Fund for Smart Trips Austin to assist residents who recently relocated to or  
31 within Austin find transportation solutions.
