#### Posting Language

Approve an inducement resolution, which will be submitted to the Texas Bond Review Board, for private activity bond financing for an allocation of up to \$21,000,000 in private activity volume cap multi-family non-recourse bonds, by Diamond Forty-Two LLC, an affiliate of O-SDA Industries LLC and Saigebrook Development LLC, for a proposed affordable multi-family development to be known as Diamond Forty-Two, located at or near 5511-5519 Jackie Robinson Street.

#### Fiscal Note

Up to \$21,000,000 of Private Activity Bonds may be issued by the Austin Housing Finance Corporation for this project. These bonds are not obligations of the City of Austin or of Austin Housing Finance Corporation, and the full faith and credit of the City is not pledged to repay these bonds.

#### Additional Backup Information:

If approved, this inducement resolution will permit staff to submit an application to the Texas Bond Review Board that requests consideration to authorize the Austin Housing Finance Corporation (AHFC) to issue multifamily housing revenue bonds in an amount up to \$21,000,000 to assist with the development of Diamond Forty-Two by Diamond Forty-Two, LLC or affiliated entities. The property is located in Council District 1.

Regulations governing the issuance of revenue bonds for the purpose of financing affordable housing specify that the bonds are non-recourse, and the full faith and credit of the AHFC or the City of Austin is not pledged to repay the bonds.

## Proposed Project

The proposed development is for 150 units to be located at 5511-5519 Jackie Robinson St. Financing for the development is proposed to come from non-competitive 4% Low Income Housing Tax Credits, and Private Activity Bonds issued by AHFC.
