**ORDINANCE NO.**

**AN ORDINANCE AMENDING ORDINANCE NO. 20190919-103 TO CORRECT THE AMENDMENT NUMBER TO THE SCHOOL DISTRICT LAND DEVELOPMENT STANDARDS AGREEMENT BETWEEN THE CITY OF AUSTIN AND THE AUSTIN INDEPENDENT SCHOOL DISTRICT.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1. FINDINGS**

- A. In this ordinance, the Original Agreement means the Land Development Standards Agreement entered into between the City and the Austin Independent School District on September 22, 1994.
- B. Ordinance No. 20190919-103, approved on all three readings by the City Council on September 19, 2019, referenced the incorrect amendment number to the Original Agreement.

**PART 2.** Part 1 of Ordinance No. 20190919-103 is amended to read as follows:

- (A) The City and the Austin Independent School District (“School District”) entered into that certain School District Land Development Standards Agreement on September 22, 1994 (“Original Agreement”), in accordance with Section 212.902 of the Texas Local Government Code.
- (B) The City and the School District have amended the Original Agreement [~~three~~ four times: in February 11, 1997, February 27, 2006, [~~and~~] April 10, 2010, and January 22, 2018 (“Agreement as Amended”).
- (C) The Agreement as Amended will expire on September 21, 2019.
- (D) The City and the School District desire to extend the term of the Agreement as Amended by five years by executing a [~~fourth~~] fifth amendment.

**PART 3.** Part 2 of Ordinance No. 20190919-103 is amended to read as follows:

Council authorizes the City Manager to execute a [~~fourth~~] fifth amendment to the Austin Independent School District Land Development Standards Agreement to extend the expiration date from September 21, 2019 to September 21, 2024.

**PART 4.** In all other respects the terms and conditions of Ordinance No. 20190919-103 remain in effect.

**PART 5.** This ordinance takes effect on \_\_\_\_\_.
