#### Additional Backup Information:

The City of Austin Parks and Recreation Department (PARD) is proposing to amend the Imagine Austin Comprehensive Plan parks and recreation element to adopt and attach the Parks and Recreation Long Range Plan for Land, Facilities and Programs. *Our Parks, Our Future* is the City of Austin Long Range Plan for Land, Facilities, and Programs. PARD's Long Range Plan for Land, Facilities and Programs. PARD's Long Range Plan for Land, Facilities and Programs is developed every 10 years and provides a blueprint to guide land acquisition, capital improvements and the development of programs and new amenities. The Long Range Plan was informed by a collaborative process with Austin residents, park partners, city staff and other stakeholders. The goal of the Parks and Recreation Long Range Plan is to:

- Assess the state of the current park system and develop a strong data-driven baseline to inform prioritization and track implementation.
- Develop a vision for Austin's park system by engaging the community and City staff to define a new vision that is both inspirational and achievable.
- Guide future growth and development of the park system through a careful analysis and strategic

investments.

• Develop park system recommendations that include both City-wide strategies and planning area priorities to inform the Capital Improvement Plan and the development of park master plans.

The future of Austin's park and recreation system is impacted by a multitude of forces, trends, and shifts including unprecedented population growth, decreasing public sector funding, increased reliance on private and philanthropic funding, and increased awareness of best practices in sustainable park development and management. The planning effort began with an inventory and evaluation of parks and facilities along with an analysis of demographic data, trends and industry standards for parks. Public outreach has played a critical role in the process, with in-depth engagement of park groups, conservancies, neighborhood associations, nonprofit organizations, and public partners. The community engagement process comprised public meetings, pop-up events, an online community survey, a statistically valid survey, focus groups, and stakeholder interviews. The PARD Long Range Plan team received more than 4,400 survey responses and more than 9,000 comments from people in all ten City Council Districts and many of the communities surrounding Austin.

Additionally, the team convened a Community Engagement Advisory Committee with representatives from all areas of the City, as well as a Technical Advisory Group with representation from all PARD divisions and City staff from Austin Transportation Department, Public Works Department, Economic Development Department, Watershed Protection Department, Office of Real Estate Services, Austin Public Library, Austin Public Health, Planning and Zoning Department, Office of Sustainability, Austin Water, Equity Office, Development Services, and the Corporate Public Information Office.

The Long Range Plan provides a summary of the critical role that parks and recreation play in how Austinites experience our City. Parks bring people together, offer recreational opportunities for residents, and provide critical environmental benefits that improve the quality of our air, water, and soil. Extensive research documents the benefits provided by public spaces, including improved physical and mental health, increased community cohesion, economic benefits, and elevated environmental services. Recommendations are structured to provide both City-wide strategies and recommendations by planning areas.
