

AUSTIN CITY COUNCIL MINUTES

REGULAR MEETING THURSDAY, OCTOBER 17, 2019

Invocation: Earlyssa 'Earl the Poet' Cooper, Poet Laureate, Huston-Tillotson University

The following represents the actions taken by the Austin City Council in the order they occurred during the meeting. While the minutes are not in sequential order, all agenda items were discussed. The City Council of Austin, Texas, convened in a regular meeting on Thursday, October 17, 2019 in the Council Chambers of City Hall, 301 West Second Street, Austin, Texas.

Mayor Adler called the Council Meeting to order at 10:18 a.m.

(MBE), for the District Cooling Plant II Exterior Tile Repair Rebid project, in the amount of \$470,955 plus a \$47,095.50 contingency, for a total contract amount not to exceed \$518,050.50. [Note: This contract will be awarded in compliance with City Code Chapter 2-9A (Minority Owned and Women Owned Business Enterprise Procurement Program) by meeting the goals with 81.01% MBE and 1.75% WBE participation.] District(s) Affected: District 9. [Note: This contract will be awarded in compliance with City Code Chapter 2-9A (Minority Owned and Women Owned Business Enterprise Procurement Program) by meeting the goals with 98.21% MBE and 1.79% WBE participation.] District(s) Affected: District 5, District 8.

The motion authorizing the award and execution of a construction contract with Facilities Rehabilitation Inc. was approved on consent on Mayor Pro Tem Garza's motion, Council Member Casar's second on a 9-0 vote. Council Members Alter and Tovo were off the dais.

5. Authorize negotiation and execution of a professional services agreement with CP&Y, Inc., (staff recommendation) or one of the other qualified responders for Request for Qualifications Solicitation No. CLM274 to provide engineering services for Hornsby Bend Biosolids Management Plant Headworks in an amount not to exceed \$750,000. [Note: This contract will be awarded in compliance with City Code Chapter 2-9B (Minority Owned and Women Owned Business Enterprise Procurement Program) by meeting the goals with 15.80% MBE and 15.80% WBE participation.]

The motion authorizing negotiation and execution of a professional services agreement with CP&Y, Inc., was approved on consent on Mayor Pro Tem Garza's motion, Council Member Casar's second on a 9-0 vote. Council Members Alter and Tovo were off the dais.

6. Authorize negotiation and execution of a professional services agreement with Carollo Engineers, Inc., (staff recommendation) or one of the other qualified responders for Request for Qualifications Solicitation No. CLMP271 to provide engineering services for the Walnut Creek Wastewater Treatment Plant Headworks Improvements project in an amount not to exceed \$1,000,000. [Note: This contract will be awarded in compliance with City Code Chapter 2-9B (Minority Owned and Women Owned Business Enterprise Procurement Program) with 15.80% MBE and 15.80% WBE participation.] District(s) Affected: District 1.

The motion authorizing negotiation and execution of a professional services agreement with Carollo Engineers, Inc., was approved on consent on Mayor Pro Tem Garza's motion, Council Member Casar's second on a 9-0 vote. Council Members Alter and Tovo were off the dais.

7. Authorize negotiation and execution of a design build agreement with Whiting-Turner Contracting Company for existing terminal centralized baggage handling system upgrades in an amount not to exceed \$16,000,000. [Note: This contract will be awarded in compliance with 49 CFR Part 26 and City Code Chapter 2-9A (Minority Owned and Women Owned Business Enterprise Procurement Program) by meeting the goals with 12.23% DBE participation.]

District(s) Affected: District 2. October 8, 2019 – Recommended by the Airport Advisory Commission on an 8-0-0-3 vote with Commissioners Saulmon, Todd, and Thies absent at this vote.

The motion authorizing negotiation and execution of a design build agreement with Whiting-Turner Contracting Company was approved on consent on Mayor Pro Tem Garza's motion, Council Member Casar's second on a 9-0 vote. Council Members Alter and Toyo were off the dais.

Item 8 was pulled for discussion.

9. Approve negotiation and execution of an automatic aid agreement with Travis County Emergency Service Districts (ESDs), Williamson County ESDs, and the cities of Leander, Cedar Park, Round Rock, and Georgetown to provide services that are mutually beneficial to the fire service agencies and residents in their respective jurisdictions, for an initial term of one year with up to nine additional one-year terms.

This item was postponed to October 31, 2019 on consent on Mayor Pro Tem Garza's motion, Council Member Casar's second on a 9-0 vote. Council Members Alter and Tovo were off the dais.

10. Approve an ordinance setting the council meeting schedule for calendar year 2020 and setting the budget and tax rate hearings for Fiscal Year 2020-2021 (Suggested dates: July 23, 2020, July 30, 2020, and August 12, 2020).

District(s) Affected: District 8.

(Note: This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program. For the services required for this solicitation, there was an insufficient availability of certified M/WBEs; therefore, no subcontracting goals were established).

16. For the services required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established).

 - The motion authorizing negotiation and execution of a cooperative contract with GTS Technology Solutions, Inc. was approved on consent on Mayor Pro Tem Garza's motion, Council Member Casar's second on a 9-0 vote. Council Members Alter and Tovo were off the dais.

Sole source contracts are exempt from the City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program; therefore, no subcontracting goals were established).

19. Authorize negotiation and execution of a multi-term cooperative contract with DLT Solutions, LLC, to provide learning management software, for up to five years for a total contract amount not to exceed \$485,000. (Note: This procurement was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9D. Minority Owned and Women Owned Business Enterprise Procurement Program. For the services required for this procurement, there were no subcontracting opportunities; therefore, no subcontracting goals were established).

The motion authorizing negotiation and execution of a multi-term cooperative contract with DLT Solutions, LLC was approved on consent on Mayor Pro Tem Garza's motion, Council Member Casar's second on a 9-0 vote. Council Members Alter and Tovo were off the dais.

20. Approve an ordinance authorizing negotiation and execution of an interlocal agreement with Capital Metropolitan Transportation Authority for up to \$22,500 for its local contribution for the Smart Trips Austin grant; amending the Fiscal Year 2019-2020 Austin Transportation Department Operating Budget Special Revenue Fund (Ordinance No. 20190910-001) to accept funds from the Capital Metropolitan Transportation Authority; and amending the Austin Transportation Department Capital Budget (Ordinance No. 20190910-001) to transfer in and appropriate funds to assist residents who recently relocated to or within Austin to find transportation solutions.

[Note: This amendment will be awarded in compliance with City Code 2-9B (Minority Owned and Women Owned Business Enterprise Procurement Program). Current participation to date is 12.55% MBE and 15.84% WBE.]

(5) Administrative Leave

A department Director may grant an employee administrative leave for a purpose approved by the City Manager. Examples of administrative leave include but are not limited to: blood bank donations, work hours lost on the day of an on the job injury, power failure, bomb threat, reduced work day by administrative directive, visits to other cities on City business, etc. A maximum of four hours of administrative leave will be granted for the purpose of voting in a federal, state, or local election (including regular, special, and run-off elections), which may be used during an early voting period or an election day. Time Charged to administrative leave will be shown as regular time worked.

"With the exception of the portion of the project that is two (2) feet to ten (10) feet above grade which is subject to the glazing requirements in 25-2-733(E)(1), the project shall be constructed with no more than 75% glass on the exterior façade and shall contain a minimum of 25% natural materials. Natural materials shall include, but are not limited to, bronze, concrete, zinc, copper or masonry. Plastic fiberglass and other products made from artificial material are prohibited on the project façade. The ground floor façades of the project facing South Lamar Boulevard, Riverside Drive and Lee Barton Road shall be constructed with a minimum of 15% natural stone, calculated on an aggregate basis. Exterior glass shall not have a reflectivity index of greater than 20 percent."

To amend subsection b.i. to read as follows:

"The first building block will have a maximum height of 96 feet and will be situated (A) along the entire length of the Project's South Lamar Boulevard edge; (B) along the entire length of the Project's Riverside Drive edge; and (C) along the Project's Lee Barton Drive edge generally from the Project's Riverside Drive edge to a point no closer than 67 feet at the ground floor and 56 feet (excluding balconies) at the floors above the ground level floor from the Project's southern property line along Lee Barton Drive; and"

To amend subsection b.ii. to read as follows:

"The second building block will have a maximum height of 86 feet, except balconies, or canopies or similar improvements other than the primary structure..."

To amend Part 8, last paragraph, to read as follows as follows:

"If for any reason Non-Profit notifies the applicant and the City in writing of its decision not to accept the cash donation described in subsection B above, or fails to acquire the site located at 1508 South Lamar Boulevard within 90 days of approval of the Ordinance, the applicant shall satisfy the requirement in subsection B above by donating the \$2,500,000 in cash to the Neighborhood Housing & Community Development Department on or before 90 days from the effective date of this Ordinance."

Council Sponsors: Council Member Ann Kitchen, Council Member Kathie Tovo, Council Member Alison Alter, Council Member Leslie Pool.

The motion to approve the ordinance was made by Council Member Kitchen and seconded by Council Member Alter.

A substitute motion to approve the ordinance with the following amendments was made by Council Member Ellis and seconded by Council Member Casar.

The amendments were as follows:

To revise Part 1 to read:

"PART 1. The caption and City Code Section 9-4-11 (Camping in Public Area Prohibited) are repealed and replaced to read as follows:

§9-4-11 CAMPING AND OBSTRUCTION IN CERTAIN PUBLIC AREAS PROHIBITED

To revise Part 1(A)(2)(a) to read: "storing personal belongings for an extended or indefinite period of time;"

To revise Part 1(A)(2)(c) to read: "using a tent or shelter or other structure for a living accommodation."

To add a new Part 1 (A)(3) to read: "HOMELESS SHELTER means a supervised publicly or privately operated facility that is designed to provide temporary living accommodations for individuals who lack a fixed, regular, and adequate residence while providing them with social service and other assistance to find a home and that is designated by the city as a shelter."

To revise Part 1 (B) to read: "Except as provided in Subsection (E), a person commits an offense if, after having been notified by a law enforcement officer that the conduct violates this section and having been given a reasonable opportunity by a law enforcement officer to correct the violating conduct, including, when applicable, the officer advising the person of a lawful alternative place to camp, the person:

- (1) camps in a public area not designated by the City of Austin as a camping area and the person is:
 - (a) materially endangering the health or safety of another person or of themselves; or
 - (b) intentionally, knowingly, or recklessly rendering impassable or impeding the reasonable use of a public area making usage of such area unreasonably inconvenient or hazardous.
- (2) camps, sits, or lies down in a public area and the person is located:
 - (a) within the area of the Austin Resource Center for Homeless (ARCH) and Salvation Army Downtown Shelter, so long as either is an operating homeless shelter, bordered by East 4th Street (South), South Bound I-35 Frontage Road (East), East 11th Street (North), and Brazos Street (West); or
 - (b) Within approximately one-quarter mile, with boundaries set by the City Manager and posted with signage, of an operating homeless shelter located outside of the area in the Central Business District; or
 - (c) Within 15 feet of a door jamb of a residence or a business during the business' operating hours.

To add a new Part 1 (C), renumbering accordingly as follows: "A person is materially endangering the health or safety of another person or of themselves, or is rendering impassable, or impeding the reasonable use of a public area making usage of such area unreasonably inconvenient or hazardous, if the person is camping on a sidewalk."

To add a new Part 1 (F), renumbering accordingly as follows: "Subsection (B)(2) does not apply to a person who is sitting or lying if the person is:

(1) in the right-of-way because of a medical emergency;

- (2) operating or patronizing a commercial establishment that conducts business on the sidewalk under Title 14 (Streets and Use of Public Property) of the Code;
- (3) participating in or viewing a parade, festival, performance, rally, demonstration or similar event;
- (4) sitting on a chair or bench that is supplied by a public agency or by the abutting private property owner;
- (5) sitting within a bus stop zone while waiting for public or private transportation; or
- (6) waiting in a line for goods, services, or a public event.

To add a new Part 1 (G), renumbering accordingly as follows: "It is an affirmative defense to prosecution for a violation of Subsection (B)(2) for sitting or lying if a person is sitting or lying and is obstructing the right-of-way, but is seated or lying down as the result of a physical manifestation of a disability, not limited to visual observation."

To add a new Part 2 to read as follows: "PART 2. INSTRUCTIONS TO CITY MANAGER.

The City Manager is directed not to enforce Subsection (B)(2) of City Code Section 9-4-11 (Camping and Obstruction in Certain Public Areas Prohibited) against individuals who are alleged to be in violation of these City Code provisions and who are, on the effective date of this ordinance, within the area around a homeless shelter as defined in Subsection (A)(3) of City Code Section 9-4-11 (Camping and Obstruction in Certain Public Areas Prohibited) beginning when the effort to relocate is initiated and ending when the following events occur:

- (I) The City Manager certifies that the City has offered appropriate services and non-shelter housing to these individuals; and
- (2) the City Manager posts on the city website a report documenting that the City of Austin has given these individuals an adequate opportunity to participate in non-shelter housing and services, that the non-shelter housing and services being offered to individuals are appropriate based on the assessments completed; and
- (3) that these individuals have been adequately educated about city rules related to camping or sitting or lying in the prohibited area around homeless shelters, and that individuals have been granted sufficient time to participate in non-shelter housing and service programs."

An amendment was made by Council Member Casar to add a new Part 1 (C) renumbering accordingly as follows:

- "A law enforcement officer must, before citing a person for a violation of this section, make a reasonable effort to:
 - (1) advise the person of a lawful alternative place to camp
 - (2) advise the person, to the best of the law enforcement officer's knowledge, of available shelter or house; and
 - (3) contacting, if reasonable and appropriate, a city designee who has the authority to offer to transport the person or provide the person with services."

The amendment was approved on Council Member Casar's motion, Mayor Pro Tem Garza's second on an 11-0 vote.

An amendment was made by Council Member Harper-Madison to amend subsection (2) of section (B) to read: "camps, or obstructs in a public area and the person is located..."

The amendment failed on Council Member Harper-Madison's motion, Mayor Pro Tem Garza's second on a 4-7 vote. Those voting aye were: Mayor Pro Tem Garza, Council Members Casar, Harper-Madison, and Renteria. Those voting nay were: Mayor Adler, Council Members Alter, Ellis, Flannigan, Kitchen, Pool, and Tovo.

An amendment was made by Council Member Alter to create a new subsection 3 under §9-4-11 (B) to read: "camps on land that the city has designated as having a high fire risk..."

The amendment was approved on Council Member Alter's motion, Council Member Kitchen's second on a 7-3 vote. Those voting aye were: Council Members Alter, Ellis, Flannigan, Kitchen, Pool, Renteria, and Tovo. Those voting nay were: Mayor Adler, Council Members Casar and Harper-Madison. Mayor Pro Tem Garza was off the dais.

An amendment was made by staff to revise subsection 3 under §9-4-11 (B) to read: "camps on land that the city has designated as having a high wildfire risk..." The amendment was accepted without objection.

An amendment was made by Council Member Pool to revise §9-4-11 (B) to include "camping, sitting, or lying in or on a storm drain or culvert". The amendment failed on Council Member Pool's motion, Council Member Kitchen's second on a 5-6 vote. Those voting aye were: Council Members Alter, Kitchen, Pool, Renteria and Tovo. Those voting nay were: Mayor Adler, Mayor Pro Tem Garza, Council Members Casar, Ellis, Flannigan and Harper-Madison.

An amendment was made by Council Member Alter to revise §9-4-11 (B)(2), adding a new part (d) to read: "on a sidewalk." The amendment failed on Council Member Alter's motion, Council Member Pool's second on a 4-7 vote. Those voting aye were: Council Members Alter, Kitchen, Pool and Tovo. Those voting nay were: Mayor Adler, Mayor Pro Tem Garza, Council Members Casar, Ellis, Flannigan, Harper-Madison and Renteria.

An amendment was made by Council Member Alter to revise §9-4-11 (C) to read: "Unless a law enforcement officer determines that there is an imminent health or safety threat, a law enforcement officer must, before citing a person for a violation of this section, make a reasonable effort to:" The amendment was approved on Council Member Alter's motion, Council Member Pool's second on a 10-0 vote. Council Member Tovo was off the dais.

An amendment was made by Council Member Kitchen to revise §9-4-11 (B) to read: "Camping, sitting, or lying down on a traffic island, median strip, median island, intersection island or other similar area under a highway overpass that separates opposing traffic flows with either a painted area or a raised curb where one of the traffic flows is a Texas U-turn lane;" The amendment failed on Council Member Kitchen's motion, Council

Member Alter's second on a 4-7 vote. Those voting aye were: Council Members Alter, Kitchen, Pool and Tovo. Those voting nay were: Mayor Adler, Mayor Pro Tem Garza, Council Members Casar, Ellis, Flannigan, Harper-Madison, and Renteria.

An amendment was made by Council Member Pool to revise §9-4-11 (B) to read: "Camping in the bed or on the bank of a creek or river". The amendment failed on Council Member Pool's motion, Council Member Tovo's second on a 4-7 vote. Those voting aye were: Council Members Alter, Kitchen, Pool, and Tovo.
