Biography



Carl F. Hunter II, M.Div. received his Bachelor of Science degree in Business Administration from Morris Brown College in Atlanta, Georgia and his Master of Divinity Degree from New Brunswick Theological Seminary where his focus and passion was in Urban Ministry. He is an Itinerant Elder in the African Methodist Episcopal Church and has served on the ministerial staffs of the following churches, Mt. Zion AME Church, Trenton, NJ; Saint James AME Church, Newark, NJ; Bethel AME Church, Far Rockaway, NY; Mt. Zion AME Church, New Brunswick, NJ; Shrewsbury Avenue AME Zion Church, Red Banl NJ. and served as pastor of Grant Chapel AME Church in Trenton, NJ.

Carl has accumulated over 20 years of experience in community organizing, organizational development, programmatic design, project planning, grant writing and personnel training. As result that accumulated experience, he was called upon

by a variety of organizations across the State of New Jersey to serve as an instructor, workshop facilitator, and panelist. He was also utilized by non-profit and for profit organizations as an organizational development consultant. Carl was one of the original founders and served as Executive Director of the S.T.A.R.S Community Development Corporation, a community-based non-profit organization in the City of Asbury Park. As Executive Director, he facilitated broad-based collaborations with local government, state agencies, trade unions and local developers to facilitated workforce development and training initiatives and the building of affordable housing for community residents and community stakeholders in the City of Asbury Park.

Carl recently retired after 25 years of service, from Mercer County Board of Social Services in Trenton, New Jersey where he worked as a Procedures Analyst. He distinguished himself at the agency through his leadership qualities and his volunteerism. He served as the coordinator of the Adopt-A-Family Initiative from 2011 to 2016. Through the forging of strategic relationships with other agencies, corporations, and private individuals over 300 families were adopted during the Thanksgiving and Christmas holidays. In 2015, the Adopt-A-Family Initiative was expanded to include a Back-to-Initiative that provided backpacks and school supplies for school aged children. Carl was recognized by the National Congress of Black Women, Trenton/Mercer Chapter in 2015 for his work in that area. However, with all of his accomplishments his passion lies in working with youth. As a motivational speaker for youth organizations such as the Program for Acceleration in Careers of Engineering (P.A.C.E.), a science and engineering awareness program for local minority high school students, he focuses on helping them understand how their choices have far reaching implications on their lives. He also designed and implemented, in collaboration with an NGO of the United Nations, the New Jersey Youth Ambassadors, a state-wide initiative for at-risk youth.

Carl relocated to Austin in October of 2017. In July of 2018, he became the Peer Policy Fellow for Recovery People, a peer and family led recovery-based non-profit that supports people in recovery from substance use and related mental health issues, through a grant provided by the Hogg Foundation. As a Hogg Fellow working for Recovery People, Carl's major objectives are to empower the voice of the recovery community and to advocate for the expansion of a wide variety of recovery support services as part of a recoveryoriented system of care. His responsibilities include researching best and emerging practices in mental health and substance use that advance policies priorities and strategies. He assists in research, providing technical assistance, and assists in the writing of fact sheets, issue briefs, and other educational materials around the areas of mental health and substance use disorder. Another task in meeting his objective is to educate policymakers and/or their staff on policy solutions that increase access to quality community-based recovery services with an emphasis on recovery housing. As an advocate and community organizer for Recovery People, it is his responsibility to collaborate with allied local and statewide organizations and institutions to ensure that recovery supported services and housing are policy priorities. During this 86th legislative session, Representative Alma Allen gave official recognition to the work and contributions of Carl and the other Hogg Peer Policy Fellows in House Resolution 1268 (HR 1268), which was read and adopted before the entire House of Representative on April 24, 2019.

Finally, Carl is a person in sustain recovery from Substance Use Disorder (SUD) and has two adult children, Ashley and Isaiah, a granddaughter named Khloe, and a god-daughter named Candice. His favorite pass times are his martial arts practices and being of service to others.


