Additional Backup Information:

The contract will provide liquid copper sulfate pentahydrate (Earth Tec QZ) to eliminate zebra mussels in the water intake systems. Earth Tec QZ is a molluscicide registered with the Environmental Protection Agency (EPA) in accordance with the Federal Insecticide Fungicide and Rodenticide Act.

Zebra mussels arrived into our drinking water in mid-2017 and have accumulated on the raw water infrastructure at each of the water plants. Earth Tec QZ will be used in response to the infestation of zebra mussels. Earth Tec QZ is the only National Sanitation Foundation Standard 60 approved product that is registered with the EPA as a molluscicide for use in control of zebra mussels.

Chameleon Industries Inc. is the sole distributor of Earth Tec QZ in the state of Texas.
