NXP USA, Inc. (Oak Hill) Semiconductors enables secure connections and infrastructure for a smarter world, advancing solutions that make lives easier, better, and safer. As the world leader in secure connectivity solutions for embedded applications, NXP USA, Inc is driving innovation in the secure connected vehicle, endto-end security & privacy, and smart connected solutions markets. Built on more than 60 years of combined experience and expertise, the company has approximately 30,000 employees in more than 30 countries and posted revenue of \$9.41 billion in 2018. In addition to the \$11,000,000 million committed under its 2015 designation, NXP USA, Inc. plans to invest an additional \$116 million over the next five years. From July 2019 through December 2024, NXP USA, Inc. anticipates spending \$116 million on capital investment projects at the Austin Technology and Manufacturing Center ("ATMC") facility, located at 3501 Ed Bluestein Blvd, Austin, Texas. Specifically, NXP USA, Inc. plans to invest \$116 million on converting office space to manufacturing space to increase manufacturing capacity which resulted in 34,000 sq./ft of office to cleanroom conversion. As a result of the added manufacturing space, NXP USA, Inc. plans to purchase and upgrade its equipment and technology capabilities for wafer manufacturing to increase production efficiencies. These equipment and facility upgrades will preserve NXP USA, Inc's ATMC facility as one of the most advanced semiconductor plants in the United States and allow NXP USA, Inc's to create 50 new full-time positions for Enterprise Zone benefit at the Austin Technology and Manufacturing Center ("ATMC"). NXP USA, Inc has 904 full-time

employees, with a total number of Full-Time Jobs to be created at 50, and total number of Jobs to be retained for benefit are 400, which meets the definition of a "retained job" in accordance with Texas Government Code 2303.401. If designated as an Enterprise Zone Project, NXP USA, Inc. would be eligible for a refund of State sales and use tax based on the employment criteria and the amount of the capital spent at the qualified business site. The Texas Legislature currently authorizes 105 state designations each biennium. The City is eligible to receive up to (9) Enterprise Project designations based on availability and competitiveness of the project ever two (2) years.
