AN ORDINANCE AMENDING THE FISCAL YEAR 2019-2020 AUSTIN POLICE DEPARTMENT OPERATING BUDGET SPECIAL REVENUE FUND (ORDINANCE NO. 20190910-001) TO ACCEPT AND APPROPRIATE GRANT FUNDS FOR THE CRIME LAB ENHANCEMENT PROJECT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Council authorizes the acceptance of \$89,777 in grant funds from the State of Texas Office of the Governor; Criminal Division, Coverdell National Forensic Sciences Improvement Act Fund for the Crime Lab Enhancement Project.





ANALYSIS / ADDITIONAL INFORMATION: The FY 2019-2020 Austin Police Department Operating Budget Special Revenue Fund includes \$200,000 in grant funding from the State of Texas, Office of the Governor, Criminal Justice Division. APD received notice of an additional award in the amount of \$89,777, bringing the total award to \$289,777 for this project. A City funding match is not required. The General Fund will not be required to contribute additional funds beyond those currently budgeted to this grant. When the grant funds expire, the Austin Police Department's need for continuing funding will be evaluated and may be denied.
