

36 **PART 4. COMPLIANCE WITH CITY CODE.**

37 The franchise holder shall comply with the provisions of the City Code relating to
38 ground transportation services and all amendments to those provisions during the period
39 of the taxicab franchise, and rules promulgated to enforce the Code provisions.

40 **PART 5. MAINTENANCE OF RECORDS.**

41 The franchise holder shall maintain complete records of all dispatched calls, all
42 expenses incurred in connection with the operation of the taxicab service business, and all
43 revenues derived from the taxicab business.

44 **PART 6. INSPECTION OF RECORDS.**

45 The franchise holder shall permit the Austin Transportation Department to inspect
46 all records of this franchise in accordance with Section 13-2-406(D) (*Recordkeeping*
47 *Requirements*) of the City Code.

48 **PART 7. TAXICAB OWNERSHIP, LEASE, OR CONTROL.**

49 The franchise holder shall own, lease, or contract for control of each taxicab used
50 in the taxicab franchise.

51 **PART 8. ANNUAL FRANCHISE PERMIT FEE.**

52 The franchise holder shall pay a permit fee for each vehicle authorized in this
53 franchise to the City of Austin at the office of the Director of the Austin Transportation
54 Department. This fee will be set by separate ordinance and may be amended by council
55 during the effective period of the franchise.

56 **PART 9. FORFEITURE.**

57 The franchise is subject to forfeiture if:

- 58 (A) the franchise holder is convicted of a violation of a provision of the City Code
59 relating to ground transportation services during the period of the taxicab
60 franchise;
- 61 (B) it is shown that the taxicab franchise holder has substantially breached the
62 terms of this franchise; or
- 63 (C) the franchise holder fails to pay an outstanding final judgment against the
64 franchise holder that arises out of circumstances related to ground
65 transportation service.

PART 10. FRANCHISE ACCEPTANCE.

The franchise holder shall file its written acceptance of the terms of this ordinance with the city clerk not later than the 60th day after the city council’s adoption of this ordinance.

PART 11. EFFECTIVE DATE.

This ordinance becomes effective on July 21, 2020, unless the franchise holder fails to file its written acceptance of this ordinance as required by Part 10 (*Franchise Acceptance*). If the franchise holder fails to file the written acceptance, this ordinance is void.
