

AUSTIN CITY COUNCIL MINUTES

REGULAR MEETING THURSDAY, APRIL 23, 2020

The following represents the actions taken by the Austin City Council in the order they occurred during the meeting. While the minutes are not in sequential order, all agenda items were discussed. The City Council of Austin, Texas, convened in a regular meeting on Thursday, April 23, 2020 via Videoconference.

Mayor Adler called the Council Meeting to order at 10:03 a.m.

 - The motion to approve the minutes of the Austin City Council work session of April 7, 2020, and regular meeting of April 9, 2020 was approved on consent on Council Member Alter's motion, Mayor Pro Tem Garza's second on an 11-0 vote.
- Approve an ordinance amending the Fiscal Year 2019-2020 Austin Resource Recovery
 Department Operating and Capital Budgets (Ordinance No. 20190910-001) related to the
 expansion of community cleanup efforts.
 - This item was postponed to May 21, 2020 on consent on Council Member Alter's motion, Mayor Pro Tem Garza's second on an 11-0 vote.

(MBE), (staff recommendations) or one of the other qualified responders for Request for Qualifications Solicitation No. CLMP289 to provide professional engineering services for the Austin Water Barton SoCo and the Travis Heights Reclaimed Water Main projects with a total amount not to exceed \$1,500,000. [Note: This contract will be awarded in compliance with City Code Chapter 2-9B (Minority Owned and Women Owned Business Enterprise Procurement Program) by meeting the goals of 15.80% MBE and 15.80% WBE participation.] District(s) Affected: District 5, District 9.

The motion authorizing negotiation and execution of a professional services agreement with K Friese and Associates, Inc. (WBE) and CAS Consulting and Services, Inc. (MBE), or one of the other qualified responders, was approved on consent on Council Member Alter's motion, Mayor Pro Tem Garza's second on an 11-0 vote.

8. Authorize negotiation and execution of an amendment to the professional services agreement with CDM Smith, Inc., for construction and post-construction phase engineering services for the North Austin Reservoir and Pump Station Improvements project in the amount of \$3,618,097, for a total contract amount not to exceed \$7,318,097. [Note: This contract will be awarded in compliance with City Code Chapter 2-9B (Minority Owned and Women Owned Business Enterprise Procurement Program). Current participation to date is 18.72% MBE and 28.22% WBE.] District(s) Affected: District 7.

The motion authorizing negotiation and execution of an amendment to the professional services agreement with CDM Smith, Inc. was approved on consent on Council Member Alter's motion, Mayor Pro Tem Garza's second on an 11-0 vote.

(MBE), for the South Austin Regional Wastewater Treatment Plant Electrical Substation No. 1 Replacement project, in the amount of \$29,989,000 plus a \$2,998,900 contingency, for a total contract amount not to exceed \$32,987,900. [Note: This contract will be awarded in compliance with City Code Chapter 2-9A (Minority Owned and Women Owned Business Enterprise Procurement Program by meeting the goals with 45.48% MBE and 25.87% WBE participation.] District(s) Affected: District 2.

The motion authorizing negotiation and execution of a 60-month lease extension with the Center for Child Protection Services was approved on consent on Council Member Alter's motion, Mayor Pro Tem Garza's second on an 11-0 vote.

18. Approve an ordinance releasing Tract 2 (55 acres) from the 5200 McKinney Falls Parkway Annexation and Development Agreement Area agreement (adjacent to District 2).

Approve an ordinance amending the Fiscal Year 2019-2020 Austin Public Health Department Special Revenue Fund (Ordinance No. 20190910-001) to accept and appropriate \$838,004 in additional grant funds from the Texas Department of State Health Services to support the Coronavirus 2019 response in alignment with the Public Health Crisis Response Cooperative Agreement for Emergency Response.

21. Authorize negotiation and execution of an interlocal agreement with Travis County to provide funding and services for the Summer Youth Employment Program for a one-year term beginning October 1, 2020 and five twelve-month renewal options each in an amount not to exceed \$371,455, for a total agreement amount not to exceed \$2,228,730.
