Posting Language

Authorize negotiation and execution of Amendment No. 1 to the agreement with Family Independence Initiative to administer an online portal to distribute direct financial assistance to Austin/Travis County residents impacted by COVID-19 to increase funding in an amount not to exceed \$10,000,000 and extend the term by two months to end on October 31, 2020 for a revised total contract amount not to exceed \$10,500,000.

Fiscal Note

Funding in the amount of \$10,000,000 is included in the COVID-19 Spending Framework (Resolution No. 20200604-040) as part of the Economic Support for Financial and Other Direct Support.

Prior Council Action:

July 29, 2020 - Council authorized ratification of an agreement with Family Independence Initiative to provide direct financial assistance to Austin/Travis County residents impacted by COVID-19 in an amount not to exceed \$500,000 for the term July 15, 2020 through August 31, 2020, with a 10-0 vote with Mayor Adler off the dais.

June 4, 2020 - Council approved Resolution No. 20200604-040 adopting the COVID-19 proposed spending framework for the use of all available federal and local funding that maximizes the benefit of federal COVID-19 relief funding and local funding, with an 11-0 vote on the virtual dais.

April 9, 2020 - Council approved Ordinance No. 20200409-87 amending the Fiscal Year 2019-2020 General Fund Emergency Reserve Fund (Ordinance 20190910-001) to appropriate an amount not to exceed \$15,000,000 for the Relief in a State of Emergency (RISE) Fund to support COVID-19 emergency relief, with an 11-0 vote on the virtual dais. On the same day, City Council approved Resolution No. 20200409-081, which authorized the City Manager to negotiate and execute new emergency contracts funded from the RISE Fund to offer immediate support services and direct financial assistance to residents impacted by the COVID-19 pandemic and economic crisis.

Approval of this item will authorize Austin Public Health to ratify Amendment 1 to the agreement with Family Independence Initiative (FII) to administer an online portal to distribute direct financial assistance to Austin/Travis County residents impacted by COVID-19.

This funding was awarded to FII as a result of the competition for funding RFQS #006 COVID-19 RISE 2.0 -

2020 - NPS. The purpose of the competition was to fund qualified social service providers with demonstrated experience to administer a secure online portal with a centralized application and process to distribute direct financial assistance through ACH transfers and pre-paid debit and credit cards to individuals impacted by COVID-19. There were two applicants for the online portal and FII received the highest score.

The original agreement with Family Independence Initiative was developed to provide direct financial assistance to Austin/Travis County residents impacted by COVID-19 in an amount not to exceed \$500,000 for the term July 15, 2020 through August 31, 2020 with no renewals.
