Posting Language

Authorize award and execution of a construction contract with Sefbo Pipeline Bridge, Inc., for the ATD - Traffic Signs and Pavement Markings Toolbox Indefinite Delivery/Indefinite Quantity contract (REBID) in the amount of \$3,440,000 for an initial one-year term, with four, one-year extension options of \$3,440,000 each, for a total contract amount not to exceed \$17,200,000.

[NOTE: This contract will be awarded in compliance with City Code Chapter 2-9A (Minority Owned and Women Owned Business Enterprise Procurement Program) by meeting the goals with a combined MBE/WBE goal of 1.75% participation.]

Additional Backup Information:

The Austin Transportation Department (ATD) is committed to providing the safest, most efficient, cost-effective, and sustainable transportation network for our community. ATD strives for a complete transportation network that serves the needs of street, bicycle, pedestrian, and transit users. ATD supports the fulfillment of this mission through the installation of multimodal street design services to include improvements to transit operations, pedestrian safety and bikeway connectivity as well as the ongoing maintenance and operation of these facilities.

This contract will serve the 2016 Mobility Bond, Local Mobility component, to provide markings, signs and the installation of other devices to support the Bicycle Program, Sidewalk Program, Safe Routes to School Program, the Transit Speed and Reliability Program and the Speed Management Program.

Indefinite Delivery/Indefinite Quantity contracts provide for an indefinite quantity of services for a fixed time, usually an initial term with extension options. They are commonly used when precise quantities of supplies or services, above a specified minimum, cannot be determined. Indefinite Delivery/Indefinite Quantity contracts help streamline the contract process and service delivery and allow the City the flexibility to add work as needs arise or change. As each project is defined, a specific work assignment will be given to the contractor who will complete the scope of work for the unit prices included in the contract. Work deadlines will be established for each work assignment.

This contract will provide the following services, including but not limited to the installation and removal of pavement markings, markers and devices on roadways throughout the City of Austin. These devices include items such as reflective pavement markings (paint, epoxy, Methyl Methacrylate, and/or thermoplastic), surface mounted channelizer posts, traffic buttons, reflectorized pavement markers (RPMs) as well as traffic signs. Work will include the placement of new pavement markings after street resurfacing activities and for maintenance of existing pavement markings. This scope also includes selected removal of existing paint, thermoplastic or other pavement markings as identified. Locations will vary based on the City of Austin's Street and Bridge resurfacing schedule and the Austin Transportation Department's striping maintenance schedule. Work assignments associated with this contract will occur throughout the City of Austin.

The base bid was used to identify and determine the lowest responsive bidder and to determine contract unit prices for each bid item.

This request allows for the award and execution of a construction contract with Sefbo Pipeline Bridge, Inc. for an estimated period of one year with four, one-year extension options. However, if funds for the initial term are expended staff may accelerate the extension options, but in no event will exceed the total contract amount. The extension options are subject to the agreement of both parties.

A delay in issuing this Contract may affect the delivery of critical improvements to City transit needs.

Projects will be located City wide, in all Districts.
