ORDER TO ESTABLISH AND APPOINT MEMBERS OF AN EARLY VOTING BALLOT BOARD AND TO ESTABLISH A CENTRAL COUNTING STATION AND APPOINT A CENTRAL COUNTING STATION PRESIDING JUDGE, CENTRAL COUNTING STATION ALTERNATE PRESIDING JUDGE, AND CENTRAL COUNTING STATION PERSONNEL, ALL FOR THE NOVEMBER 3, 2020 JOINT GENERAL AND SPECIAL ELECTIONS

Recitals

- 1. Pursuant to Texas Election Code Section 87.001, the Travis County Commissioners Court is required to establish an early voting ballot board to process early voting results for the November 3, 2020 Joint General and Special Elections, which the Travis County Clerk is conducting.
- 2. Texas Election Code Section 87.002(b) provides that the presiding judge of the early voting ballot board is appointed in the same manner as presiding election judges appointed under Texas Election Code Section 32.002.
- 3. Texas Election Code Section 127.001 authorizes the Travis County Commissioners Court to establish a central counting station to have ballots counted at a central location for the November 3, 2020 Joint General and Special Elections.
- 4. Texas Election Code Section 127.002 requires that the Travis County Commissioners Court appoint a manager for the central counting station.
- 5. Texas Election Code Section 127.003 requires that the Travis County Commissioners Court appoint a tabulation supervisor for the central counting station.
- 6. Texas Election Code Section 127.004 authorizes the tabulation supervisor to appoint one or more assistants to the tabulation supervisor for the central counting station.
- 7. Texas Election Code Section 127.005 requires that the Travis County Commissioners Court appoint a presiding judge and an alternate presiding judge of the central counting station.

NOW, THEREFORE, the Travis County Commissioners Court hereby appoints as Presiding Judge, Alternate Presiding Judge, Manager, and Tabulation Supervisor of the Central Counting Station, and as Presiding Judge, Alternate Presiding Judge, and Members of the Early Voting Ballot Board, those named individuals so designated in Exhibit A, attached hereto and hereby incorporated by reference herein for all purposes as if fully copied and set forth herein at length.

The Presiding Judge, Alternate Presiding Judge, Manager, and Tabulation Supervisor of the Central Counting Station, and the Presiding Judge, the Alternate Presiding Judge, and

the Members of the Early Voting Ballot Board shall serve in the November 3, 2020 Joint General and Special Elections, which the Travis County Clerk is conducting.

The Alternate Presiding Judge of the Central Counting Station shall serve as Presiding Judge of the Central Counting Station if the Presiding Judge appointed hereunder cannot serve in the election. In the alternative, the Alternate Presiding Judge of the Central Counting Station may serve in another position established under Chapter 127, Subchapter A, Texas Election Code.

BE IT SO ORDERED on this 29th day of September 2020.
