Public notice was given for this solicitation, CLMC800, Transportation Safety and Mobility Improvements IDIQ, through the City's Vendor Connection web portal. Five bids were received and opened on August 27, 2020. Of the five bids received, three bids were from MBE/WBE certified firms.
