

**ORDINANCE NO. 20200917-006**

**AN ORDINANCE ACCEPTING GRANT FUNDS FROM THE TEXAS DEPARTMENT OF EMERGENCY MANAGEMENT AND AMENDING THE FISCAL YEAR 2019-2020 OPERATING BUDGET SPECIAL REVENUE FUND (ORDINANCE NO. 20190910-001) FOR THE FOLLOWING DEPARTMENTS: ANIMAL SERVICES DEPARTMENT, AUSTIN CODE DEPARTMENT, AUSTIN ENERGY, AUSTIN FIRE DEPARTMENT, AUSTIN POLICE DEPARTMENT, AUSTIN PUBLIC HEALTH, AUSTIN PUBLIC LIBRARY, AUSTIN RESOURCE RECOVERY, AUSTIN WATER DEPARTMENT, AVIATION, COMMUNICATIONS AND TECHNOLOGY MANAGEMENT, CORPORATE PUBLIC INFORMATION OFFICE, EMERGENCY MEDICAL SERVICES, FLEET SERVICES DEPARTMENT, HOMELAND SECURITY AND EMERGENCY MANAGEMENT, HUMAN RESOURCES DEPARTMENT, PARKS AND RECREATION DEPARTMENT, PLANNING AND ZONING, AND WATERSHED PROTECTION; AND AMENDING AND TRANSFERRING IN FUNDS FOR THE FISCAL YEAR 2019-2020 AUSTIN WATER CAPITAL BUDGET (ORDINANCE NO. 20190910-001).**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** Council accepts grant funds from Texas Department of Emergency Management in the amount of \$2,749,847 for city departments that sustained losses due to the flooding of October 2018.

**PART 2.** Council amends the Fiscal Year 2019-2020 Operating Budget Special Revenue Fund (Ordinance No. 20190910-001) to appropriate \$2,749,847 for the following departments: Animal Services Department \$2,284, Austin Code Department \$4,970, Austin Energy \$81,825, Austin Fire Department \$129,671, Austin Police Department \$75,045, Austin Public Health \$24,970, Austin Public Library \$3,914, Austin Resource Recovery \$20,215, Austin Water Department \$1,952,301, Aviation \$1,278, Communications and Technology Management \$3,908, Corporate Public Information Office \$2,677, Emergency Medical Services \$5,258, Homeland Security and Emergency Management \$61,175, Human Resources Department \$3,878, Parks and Recreation Department \$297,848, Planning and Zoning Department \$1,229, Watershed Protection Department \$2,218 for losses sustained due to the flooding of October 2018.

**PART 3.** Council amends the Fiscal Year Capital Budget (Ordinance No. 20190910-001) to transfer in \$106,600 from the Fiscal Year 2019-2020 Operating Budget Special


Revenue Fund (Ordinance No. 20190910-001) for Austin Water for damages sustained to the Davis and Ulrich Water Treatment Plant Projects due to the flooding of October 2018.

**PART 4.** This ordinance takes effect on September 28, 2020.




