AHFC1. Authorize negotiation and execution of an agreement with DMA Development Company, LLC & Big Medium or other qualified respondent to the 900 Gardner RFP to develop approximately 6 acres for affordable housing purposes located at or near 900 Gardner Road. District(s) Affected: District 3.

**The motion authorizing the negotiation and execution of an agreement with Vecino Group & Guadalupe Neighborhood Development Corporation was approved on Director Renteria's motion, Director Casar's second on a 9-0 vote. Director Flannigan abstained. Vice President Garza was off the dais.**

AHFC2. Authorize negotiation and execution of an agreement with MRE Capital & Imagine Art or other qualified respondent to the 1127 Tillery RFP to develop approximately 5.15 acres for affordable housing purposes located at or near 1127 Tillery Street. District(s) Affected: District 3.
