

**M/WBE Summary**

Public notice was given for this Request for Qualifications CLMP305 2021 Stream Restoration and Stormwater Treatment Engineering Services Rotation List, through the City's Vendor Connection web portal. Sixteen firms submitted qualifications statements and responses were opened on August 31, 2020. Of the 16 submittals received two submittals were from MBE/WBE certified firms.

Participation goals stated in the solicitation were 1.90% African American; 9.00% Hispanic; 4.90% Native Asian; and 15.80% WBE. The recommended firms provided an MBE/WBE Compliance Plan that met the goals of the solicitation and were approved by the Small and Minority Business Resources Department.
