AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE PROPERTY LOCATED AT 1709 AND 1803 EVERGREEN AVENUE AND 1204 WEST MARY STREET FROM GENERAL COMMERCIAL SERVICES (CS) DISTRICT AND FAMILY RESIDENCE (SF-3) DISTRICT TO GENERAL COMMERCIAL SERVICES-MIXED USE (CS-MU) COMBINING DISTRICT ON TRACT 1 AND FROM MULTIFAMILY RESIDENCE MEDIUM DENSITYHISTORIC LANDMARK (MF-3-H) COMBINING DISTRICT TO GENERAL OFFICE-MIXED USE-HISTORIC LANDMARK (GO-MU-H) COMBINING DISTRICT ON TRACT 2.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to change the base district from general commercial services (CS) district and family residence (SF-3) district to general commercial services-mixed use (CS-MU) combining district on Tract 1 and from multifamily residence medium density-historic landmark (MF-3-H) combining district to general office-mixed use-historic landmark (GO-MU-H) combining district on Tract 2 on the property described in Zoning Case No. C14-20200097, on file at the Housing and Planning Department, as follows:

## Tract 1:

Being 1.0194 acres of land situated in the Isaac Decker League, Abstract No. 8, Travis County, Texas, said 1.0194 acres of land being more particularly described by metes and bounds in Exhibit "A" incorporated into this ordinance, and

## Tract 2:

Being 0.3019 acre of land situated in the Isaac Decker League, Abstract No. 8, Travis County, Texas, said 0.3019 acre of land being more particularly described by metes and bounds in Exhibit "B" incorporated into this ordinance (collectively referred to as the "Property"),
locally known as 1709 and 1803 Evergreen Avenue and 1204 West Mary Street in the City of Austin, Travis County, Texas, generally identified in the map attached as Exhibit "C".
