# Posting Language

Authorize an amendment to an existing contract with Calytera US, Inc., for continued software maintenance and support, for an increase in the amount of \$600,000 and to extend the term up to 18 months, for a revised total contract amount not to exceed \$3,792,969.

## Additional Backup Information:

The proposed amendment provides for continued maintenance, support, consulting services, system enhancements, and licenses for the Municipal Court's Judicial Enforcement Management System (JEMS). This software system is used by Municipal Court for daily operations, including case management, electronic signatures, court process automation, docket scheduling, warrant processing, websites for attorneys, officers and the public, and acceptance of online payments. JEMS also interfaces with other departments, vendors and state agencies, workflow imaging, and electronic documents. This system provides functions and processing for all aspects of the hundreds of thousands of cases and millions of documents processed by the Municipal Court each year.

JEMS is proprietary and wholly owned by Calytera US, Inc. They are the sole provider of enhancements, maintenance and support.

Continued JEMS maintenance and support is necessary to prevent failure of the current case management system.
