development that serves the same type of household as the Development and has 20 received an allocation of Housing Tax Credits (or private activity bonds) since January 21 4, 2018. 22 **BE IT FURTHER RESOLVED:** 23 Pursuant to Section 2306.6703(a)(4) of the Texas Government Code and 24 Sections 11.3 and 11.4 of Texas' Qualified Allocation Plan, the City Council supports 25 the Proposed Development; approves the construction of the Proposed Development; 26 authorizes an allocation of Housing Tax Credits for the Proposed Development; and 27 authorizes the Proposed Development to move forward. 28 **BE IT FURTHER RESOLVED:** 29 Pursuant to Section 11.9(d)(1) of Texas' Qualified Allocation Plan and Section 30 2306.6710(b) of the Texas Government Code, the City Council confirms that it 31 32 supports the Proposed Development. 33 **BE IT FURTHER RESOLVED:** The City Council authorizes, empowers, and directs Jannette S.
