#### Posting Language

Authorize negotiation and execution of an amendment to the professional services agreement with the following eleven firms for Request for Qualifications Solicitation No. CLMP240: Kimley-Horn and Associates, Inc.; Halff Associates, Inc.; Freese and Nichols, Inc.; AECOM Technical Services, Inc.; CDM Smith, Inc.; CP&Y, Inc.; Binkley & Barfield, Inc.; Lockwood, Andrews & Newman, Inc.; Alliance-Texas Engineering Company, dba Alliance Transportation Group, Inc.(WBE); Brown & Gay Engineers, Inc.; and Dannenbaum Engineering Company - Austin LLC for engineering services for the 2018 Corridor Program Engineering Services Rotation List, in the amount of \$20,000,000.00, for a total contract amount not to exceed \$95,000,000 divided among the firms.

[Note: This contract was awarded in compliance with Chapter 2-9B of the City Code (Minority Owned and Women Business Enterprise Procurement Program). Current Participation to date is 9.08% MBE and 17.99% WBE.]

#### Additional Backup Information:

As a standard business practice, the City routinely engages the services of professional engineering firms to perform analysis, design and support services associated with construction or improvement of City capital assets. Rotation List contracting allows the City to always have a group of qualified consultants available to perform a specific type of recurring work in a timely manner to meet the project and operational needs of the

City.

In April 2019 Council approved further design and implementation of the Corridor Construction Program to allow for the next phases of the program and will utilize previously approved 2016 Mobility Bond funds. The Corridor Construction Program's design efforts have now progressed so that the continuation of current professional services is necessary.

The selected firms for the 2018 Corridor Program Engineering Services Rotation List provide civil engineering for bicycle, pedestrian, transit, and vehicle transportation infrastructure needs and facilities for the following Corridor Construction Program projects:

- North Lamar Blvd. from U.S. 183 to Howard Lane
- Burnet Road from Koenig Lane to MoPac Expressway
- Airport Blvd. from North Lamar Blvd. to U.S. 183
- E. Martin Luther King Jr. Blvd./FM 969 from U.S. 183 to Webberville Road
- South Lamar Blvd. from Riverside Drive to SH 71
- East Riverside Drive from I-35 to SH 71
- Guadalupe Street from West Martin Luther King Jr. Blvd. to West 29<sup>th</sup> Street
- Slaughter Lane from FM 1826 to Vertex Road
- William Cannon Drive from Southwest Parkway to McKinney Falls Parkway

The remaining authority under this contract will soon be expended and will not meet the needs required by the Corridor Program Office. Therefore, the Capital Contracting Office is requesting additional authorization to meet the needs of the program. The additional authority will support the program to continue implementation of the Corridor Construction Program. Per firm authorizations may be increased or decreased, through the life of the contract, based on the needs of a particular assignment and will follow the established rotation list policies and procedures.

This amendment is pending review by the City's Change Control Committee. The Change Control Committee was established to comply with Council Resolution No. 20120126-048, which required the establishment of consistent criteria and process to evaluate contractual changes for all contracts administered by the Capital Contracting Office. The Change Control Committee is comprised of management-level subject matter experts.
