Authorize an amendment to the construction contract with Restek, Inc., for the 2018-2021 Bridge Maintenance Indefinite Delivery/Indefinite Quantity contract for additional funding in the amount of \$351,500, for a total contract amount not to exceed \$2,062,500.

[Note: This contract was awarded in compliance with City Code 2-9A (Minority Owned and Women Owned Business Enterprise Procurement Program). Current participation to date is 5.83% MBE and 0.69% WBE.]

Additional Backup Information:

The Public Works Department Bridge Maintenance program was created in 2003 with the intent to expediently rehabilitate structures that are at risk of failing or have been damaged by traffic collisions, flooding, fire and/or aging. The work could also include complex bridge repairs that require specialized equipment, personnel, and materials. The work generally consists of providing services such as repairing, restoration or strengthening of major structural elements such as exposed bridge supports; preservation of stone arch bridges; channel scour remediation; replacement of rock riprap; curb and gutter, driveway and sidewalk; installation of metal beam

guard fence; replacement of deteriorated bridge railing; concrete repair; railing post reconstruction; joint seals; deck treatments; milling and asphalt overlay; and striping for maintenance work on selected bridges. The scope includes all required permits, traffic control and environmental control measures necessary to perform the work.

Additional funding for this contract is requested due to newly identified urgent repairs required for three bridge structures (+20 feet each): McKinney Falls Parkway bridge over Onion Creek; Gracy Farms bridge over Walnut Creek; and Slaughter Lane bridge over the Union Pacific Railroad track. The remaining authorization is not sufficient to cover the cost of repairs for all three bridges.

The repairs need to be done in a timely manner to ensure the structural integrity of the bridges. Delay in the approval of this amendment could compromise the use of these structures.

This change order has been approved by the City's Change Control Committee. The Change Control Committee was established to comply with Council Resolution No. 20120126-048, which required the establishment of consistent criteria and process to evaluate contractual changes for all contracts administered by the Capital Contracting Office. The Change Control Committee is comprised of management-level subject matter experts.
