PART 1. In accordance with Chapters 103 and 104 of the Texas Utilities Code, the City has exclusive original jurisdiction over gas rates charged for natural gas utility services provided in the City.

- **PART 2.** On February 11, 2021, Texas Gas Service Company (TGS) filed a
- proposed interim rate adjustment with the City of Austin, Texas (the City) that
- would allow TGS to recover the incremental costs of the new investment it has
- made within its Central Gulf Service Area (CGSA) from January 1, 2020, through
- December 31, 2020. TGS filed the same request with the other cities it serves in
- 16 the CGSA: Bayou Vista, Beaumont, Bee Cave, Cedar Park, Cuero, Dripping
- 17 Springs, Galveston, Gonzales, Groves, Jamaica Beach, Kyle, Lakeway, Lockhart,
- Luling, Nederland, Nixon, Port Arthur, Port Neches, Rollingwood, Shiner, Sunset
- 19 Valley, West Lake Hills and Yoakum. TGS is seeking an interim system-wide rate
- 20 increase of \$10,714,728 from customers in the CGSA.

PART 3. TGS proposed an effective date of April 12, 2021, for applying the rate resulting from the interim rate adjustment.

PART 4. Pursuant to Texas Utilities Code § 104.301(a), the City is authorized to suspend the implementation of the interim rate adjustment for a period not to exceed 45 days beyond the effective date proposed by TGS.
