Additional Backup Information:

The proposed amendment is to provide continued teleconference management services. Tele Town Hall, LLC assists the City in managing and queueing the citizens speaking at virtual Council meetings. This service was sought in response to the COVID-19 emergency. As a result of the custom designed telecommunications services offered by Tele Town Hall, LLC., the citizens of Austin have access to Council meetings via teleconference. Due to the continuation of the COVID-19 emergency, additional funding is required to continue the required teleconferences.

Tele Town Hall, LLC is the sole producer, designer, manufacturer, and host of the teleconference management service utilized by the City for virtual Council meetings. To allow for public input from citizens in batches, Tele Town Hall, LLC designed a service to merge multiple teleconferences in the background without interrupting the current teleconference batch of speakers. This feature was custom designed specifically for the City of Austin. This allows the City to accept one batch after another without having to interrupt the meetings to switch teleconferences. The batch caller feature also enhances the citizens' experience by reducing wait times.
