Posting Language

Authorize an amendment to an existing contract with Ungerboeck Systems International Inc. d/b/a Ungerboeck Software International, for continued event booking software and system services, for an increase in the amount of \$307,000 and to extend the term by two years, for a revised total contract amount not to exceed \$1,715,585.
