**SPECIAL CALLED MEETING  
THURSDAY, APRIL 1, 2021**

The City Council of Austin, Texas, convened in a special called on Thursday, April 1, 2021 via Videoconference.

Mayor Adler called the Council Meeting to order at 10:02 a.m.
