Public notice was given for this solicitation, CLMC834 Lake Austin - Meredith St. Storm Drain Improvements, through the City's Vendor Connection web portal. Nine bids were received and opened on February 25, 2021. Of the nine bids received, six bids were from MBE/WBE certified firms.
