

### **M/WBE Summary**

Public notice was given for this solicitation, CLMC835, 2016 Bond Intersections Safety Improvements Construction II, through the City's Vendor Connection web portal. Four bids were received and opened on April 1, 2021. Of the four bids received one bid was from a MBE/WBE certified firm. Sefbo Pipeline Bridge, Inc.
