

M/WBE Summary

Public notice was given for this solicitation, CLMC853 Rosewood Neighborhood Park – Court Renovation project, through the City's Vendor Connection web portal. Three bids were received and opened on May 20, 2021. Of the three bids received, one bid was from a M/WBE certified firm. Rider Construction Group, LLC submitted the lowest responsive bid of three bids received:
