

ORDINANCE NO.

AN ORDINANCE LEVYING MUNICIPAL PROPERTY (AD VALOREM) TAXES FOR THE CITY OF AUSTIN, TEXAS, FOR FISCAL YEAR 2021-2022.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The City Council levies, approves, and orders to be assessed and collected for the Fiscal Year 2021-2022, and for each subsequent calendar year until otherwise ordained, on all property in the limits of the City of Austin that is not exempt from taxation, a property (ad valorem) tax at the rate of \$_______ per \$100 of taxable value. The tax rate consists of two components, each of which are separately approved by Council: \$_______ per \$100 of taxable value, the rate that, if applied to the total taxable value, will impose the total amount published under Section 26.04(e)(3)(C) of the Texas Property Tax Code (Tax Code), less any amount of additional sales and use tax revenue that will be used to pay debt service; and \$______ per \$100 of taxable value, the rate that, if applied to the total taxable value, will impose the amount of taxes needed to fund maintenance and operation expenditures of the City for the coming year.

PART 2. Council sets the operations and maintenance rate in accordance with Texas Tax Code Section 26.042 for this year due to the disaster declared by Texas Governor Greg Abbott for all 254 counties in Texas because of the physical damage caused by winter storm Uri.

PART 3. The Council adopts the following property tax exemptions as further described in Exhibits "A" and "B-1" and "B-2":

Agriculture Exhibit A

Disabled Veterans Exhibit A

Straight Disability Local Option Exhibit A

Elderly Homestead Exhibit A

Residence Homestead Exhibit A

Historic – State Landmarks Exhibit B-1

Historic – City Landmarks Exhibit B-2

Council finds that all of the properties identified in Exhibit B-1 are 30 designated as Recorded Texas Historic Landmarks or as state recorded 31 archeological landmarks in accordance with Section 11.24(1) of the Tax Code. 32 Council finds that all of the properties identified in Exhibit B-2 are 33 designated as a historically or archeologically significant site in need of tax relief 34 to encourage its preservation pursuant to Section 11.24(2) of the Tax Code. 35 The exemption amounts for the properties identified in Exhibit B-1 and B-2 36 shall be determined as set forth in City Code Section 11-1-22. 37 PART 4. THIS TAX RATE WILL RAISE MORE TAXES FOR 38 MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. 39 PART 5.
