AN ORDINANCE AUTHORIZING THE ISSUANCE AND SALE OF CITY OF AUSTIN, TEXAS CERTIFICATES OF OBLIGATION, SERIES 2021; ESTABLISHING PARAMETERS FOR THE SALE OF THE CERTIFICATES; APPROVING RELATED DOCUMENTS; ENACTING OTHER PROVISIONS RELATED TO THE CERTIFICATES; AND DECLARING AN IMMEDIATE EFFECTIVE DATE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. FINDINGS

(A) On June 10, 2021, Council of the City authorized and directed that a notice of its intention to issue the Certificates (hereinafter defined) be published in a newspaper as required by Section 271.049 of the Texas Local Government Code; and

(B) The notice was published in *The Austin American-Statesman*, as required by Section 271.049 of the Texas Local Government Code, on June 21, 2021 and June 28, 2021; and

(C) No petition, signed by 5% of the qualified electors of the City as permitted by Section 271.049 of the Texas Local Government Code protesting the issuance of the Certificates, has been filed; and

(D) No bond proposition to authorize the issuance of bonds for the same purpose as any of the projects being financed with the proceeds of the Certificates was submitted to the voters of the City during the preceding three years and failed to be approved; and

(E) Council is now authorized and empowered to proceed with the issuance and sale of the Certificates pursuant to Subchapter C of Chapter 271 of the Texas Local Government Code; and

(F) Council desires to delegate to the Authorized Representative (defined below) the authority to effect the sale of the Certificates authorized by this Ordinance, subject to the parameters prescribed by this Ordinance; and

(G) The meeting at which this Ordinance is considered is open to the public as required by law, and the public notice of the time, place and purpose of the meeting was given as required by Chapter 551 of the Texas Government Code.

PART 2. DEFINITIONS

The terms used in this Ordinance have the following meanings:

“Authentication Certificate” means the Paying Agent/Registrar’s Authentication Certificate, in the form identified in the Form of Certificate.

“Authorized Denomination” means \$5,000 or any integral multiple of \$5,000.

“Authorized Representative” means the City Manager or the Chief Financial Officer of the City.

“Bidding Instructions” means the bidding instructions prepared in connection with the sale of the Certificates.

“Business Day” means a day other than a Saturday, a Sunday, a legal holiday, or a day on which banking institutions are authorized by law or executive order to close in the City or the city where the Designated Payment/Transfer Office of the Paying Agent/Registrar is located.

“Certificates” means the certificates of obligation of the City to be issued under authority of this Ordinance, including the Initial Certificate.

“Chapter 9” means Chapter 9 of the Texas Business & Commerce Code.

“Chapter 363” means Chapter 363 of the Texas Health and Safety Code.

“Chapter 1204” means Chapter 1204 of the Texas Government Code.

“Chapter 1206” means Chapter 1206 of the Texas Government Code.

“Chapter 1208” means Chapter 1208 of the Texas Government Code.

“Chapter 1371” means Chapter 1371 of the Texas Government Code.

“City” means the City of Austin, Texas.

“Code” means the Internal Revenue Code of 1986, as amended.

“Comptroller” means the Comptroller of Public Accounts of the State of Texas.

“Council” means the City Council of the City.

“Defeasance Securities” means (i) direct, noncallable obligations of the United States of America, including obligations that are unconditionally guaranteed by the

69 United States of America and (ii) noncallable obligations of an agency or instrumentality
70 of the United States of America, including obligations that are unconditionally
71 guaranteed or insured by the agency or instrumentality and that, on the date of approval
72 of the proceedings authorizing the issuance of the refunding bonds, are rated as to
73 investment quality by a nationally recognized investment rating firm not less than “AAA”
74 or its equivalent.

75 “Defeased Certificate” means any Certificate and the interest on the Certificate that
76 is considered to be paid, retired and no longer outstanding under the terms of this
77 Ordinance, specifically PART 17 of this Ordinance.

78 “Designated Payment/Transfer Office” means the office of the Paying
79 Agent/Registrar identified by the Paying Agent/Registrar as its Designated
80 Payment/Transfer Office for the purpose of discharging its duties under this Ordinance.

81 “DTC” means The Depository Trust Company, New York, New York.

82 “Event of Default” has the meaning described in PART 18 of this Ordinance.

83 “Expiration Date” means February 25, 2022.

84 “Future Escrow Agreement” means an escrow agreement or other similar
85 instrument with respect to Defeased Certificates.

86 “Initial Certificate” has the meaning described in PART 12 of this Ordinance.

87 “Interest and Sinking Fund” means the Interest and Sinking Fund established in
88 PART 9 of this Ordinance.

89 “MSRB” means the Municipal Securities Rulemaking Board.

90 “Official Bid Form” means the bid form to be submitted by bidders seeking to
91 purchase the Certificates.

92 “Paying Agent/Registrar” means U.S. Bank National Association, and its
93 successors and assigns as provided in the Paying Agent/Registrar Agreement.

94 “Paying Agent/Registrar Agreement” means the agreement between the City and
95 the Paying Agent/Registrar with respect to the Certificates in the form approved by an
96 Authorized Representative, and any successor agreement.

97 “Project” means a project for which proceeds of the Certificates are spent
98 consistent with the purposes described in clause (a) of PART 3 of this Ordinance.

99 “Purchasers” means the entity or entities listed in the Official Bid Form accepted
100 by the City as the best bid for the Certificates.

102 “Registered Owner” means the owner of any Certificate as recorded in the
103 Registration Books.

104 “Registration Books” means the books or records of registration and transfer of the
105 Certificates maintained by the Paying Agent/Registrar.

106 “Rule” means SEC Rule 15c2-12.

107 “SEC” means the United States Securities and Exchange Commission.

108 “Surplus Revenues” shall mean those revenues from the operation of the City’s
109 solid waste disposal system remaining after payment of all operation and maintenance
110 expenses of the system and other obligations incurred to which the revenues have been or
111 shall be encumbered by a lien on and pledge of such revenues superior to the lien on and
112 pledge of the revenues to the Certificates.

113 “Treasury Regulations” means all applicable temporary, proposed and final
114 regulations and procedures promulgated under the Code or promulgated under the
115 Internal Revenue Code of 1954, to the extent applicable to the Code.

117 **PART 3. CERTIFICATES AUTHORIZED**

118 The Certificates shall be issued in accordance with the Constitution, laws of the
119 State of Texas, and the Charter of the City, in one or more series, in the aggregate
120 principal amount not to exceed \$43,930,000 for the purposes of (a) financing the Projects
121 described in Schedule I and (b) paying the costs of issuance associated with the sale of
122 the Certificates. The aggregate principal amount and the designation of Certificates
123 issued pursuant to this Ordinance shall be set forth in the Bidding Instructions and the
124 Official Bid Form. The Certificates shall be numbered consecutively from R-1 upward,
125 except the Initial Certificate shall be numbered T-1.

126 **PART 4. SALE PARAMETERS**

127 (A) The Certificates shall be issued in any Authorized Denomination as fully
128 registered obligations, without interest coupons, payable to the respective initial registered
129 owners of the Certificates, or to the registered assignee or assignees of the Certificates,
130 maturing not later than 40 years from their issue date, payable serially or otherwise on the
131 dates, in the years and in the principal amounts, and dated and numbered, all as set forth in
132 the Official Bid Form.

(B) In accordance with Chapter 1371, each Authorized Representative, acting for and on behalf of the City, is authorized to seek competitive bids for the sale of the Certificates authorized to be sold by this Ordinance, and is hereby authorized to prepare and distribute the Bidding Instructions and the Official Bid Form with respect to seeking competitive bids for the sale of the Certificates. The Bidding Instructions shall contain the terms and conditions relating to the sale of the Certificates, including the date bids for the purchase of the Certificates are to be received, the date of the Certificates, any additional designation or title by which the Certificates shall be known, the aggregate principal amount of the Certificates to be sold, the price at which the Certificates will be sold, the years in which the Certificates will mature, the rate or rates of interest to be borne by each such maturity, the interest payment periods, and all other matters relating to the issuance, sale and delivery of the Certificates so sold including, without limitation, the use of municipal bond insurance for the Certificates. The Certificates shall bear interest at the rates per annum set forth in the Official Bid Form accepted as the best bid. The interest on the Certificates shall be payable to the Registered Owner of any Certificate on the dates and in the manner provided in Exhibit A. Interest on the Certificates shall be payable on the dates set forth in the Official Bid Form, until maturity or prior redemption. Each Authorized Representative, acting for and on behalf of the City, is hereby authorized to receive and accept bids for the sale of Certificates in accordance with the Bidding Instructions on such date as determined by an Authorized Representative. The Certificates shall be sold at such price as an Authorized Representative of the City shall determine to be the most advantageous to the City, which determination shall be evidenced by the execution of the Official Bid Form submitted by the best and winning bidder. One Certificate in the principal amount maturing on each maturity date as set forth in the Official Bid Form shall be delivered to the Purchasers, and the Purchasers shall have the right to exchange such Certificates as provided in PART 7 of this Ordinance without cost. Exhibit A shall be revised to reflect the terms of the sale of the Certificates as reflected in the Official Bid Form accepted as the best bid for the Certificates. The Certificates shall initially be registered in the name as set forth in the Official Bid Form. In case any officer whose signature shall appear on the Certificates shall cease to be such officer before the delivery of the Certificates, the signature shall be valid and sufficient for all purposes the same as if the officer had remained in office until delivery. An Authorized Representative shall not execute the Official Bid Form unless the best bidder has confirmed to an Authorized Representative that either it has made disclosure filings to the Texas Ethics Commission in accordance with Section 2252.908, Texas Government Code or is exempt from making such filings under Section 2252.908(c)(4), Texas Government Code. Within thirty (30) days of receipt of any disclosure filings from the best bidder for the Certificates, the City will acknowledge such disclosure filings in accordance with the rules of the Texas Ethics Commission. Any finding or determination made by an Authorized Representative relating to the issuance and sale of the Certificates shall have the same force and effect as

174 a finding or determination made by Council; *provided*, that (i) the price to be paid for the
175 Certificates shall not be less than 95% of the aggregate principal amount of the
176 Certificates sold, plus accrued interest, if any, (ii) the Certificates shall not bear interest at
177 a rate greater than the maximum rate allowed by Chapter 1204, (iii) the Certificates shall
178 not have a final maturity beyond September 1, 2041, and (iv) prior to the execution of the
179 Official Bid Form by an Authorized Representative, the Certificates shall be rated by a
180 nationally recognized rating agency for municipal securities in one of the four highest
181 rating categories for long-term debt instruments.

182 (C) An Authorized Representative may approve modifications to this Ordinance
183 to conform to the terms of the Certificates, as approved by the Authorized Representative,
184 and execute any instruments, agreements and other documents as the Authorized
185 Representative shall deem necessary or appropriate in connection with the issuance, sale
186 and delivery of Certificates pursuant to this Ordinance.

187 (D) It is in the best interests of the City for the Certificates to be sold through a
188 competitive sale, and Council authorizes each Authorized Representative, individually but
189 not collectively, to execute the Official Bid Form to evidence the acceptance by the City
190 of the terms and conditions relating to the sale of the Bonds, at the price the Authorized
191 Representative executing the Official Bid Form determines to be the most advantageous to
192 the City. The conditions set forth in PART 13 of this Ordinance must be met prior to any
193 Authorized Representative executing the Official Bid Form.

194 (E) The authority of an Authorized Representative to execute the Official Bid
195 Form shall expire at 11:59 p.m. on the Expiration Date. Certificates sold pursuant to the
196 Bidding Instructions and an Official Bid Form executed on or before the Expiration Date
197 may be delivered after the Expiration Date.

198 (F) In establishing the aggregate principal amount of the Certificates of any series,
199 the Authorized Representative shall establish an amount which shall be sufficient (together
200 with any premium received from the sale of the Certificates) to provide for the purposes
201 for which the Certificates are authorized. The Certificates of shall be sold at such price,
202 with and subject to such terms, as set forth in the Bidding Instructions and the Official Bid
203 Form.

204 (G) Any finding or determination made by an Authorized Representative relating
205 to the issuance and sale of the Certificates and the execution of the Official Bid Form shall
206 have the same force and effect as a finding or determination made by Council.

PART 5. REDEMPTION PROVISIONS

(A) The Certificates may be subject to redemption, at the option of the City, prior to their stated maturities to the extent and in the manner provided in the Bidding Instructions and the Official Bid Form. The years of maturity of the Certificates called for redemption at the option of the City prior to stated maturity shall be selected by the City. The Certificates or any portion redeemed within a maturity shall be selected by lot, or other customary random selection method, by the Paying Agent/Registrar; *provided*, that during any period in which ownership of the Certificates is determined only by a book entry at DTC, if fewer than all of the Certificates of the same maturity and bearing the same interest rate are to be redeemed, the particular Certificates of such maturity and bearing such interest rate shall be selected in accordance with the arrangements between the City and DTC.

(B) The Certificates may be subject to mandatory sinking fund redemption prior to their stated maturities, to the extent and in the manner provided in the Official Bid Form.

(C) At least 30 days before the date fixed for redemption, the City shall cause a written notice of the redemption to be deposited in the United States mail, first-class postage prepaid, addressed to each Registered Owner at the address shown on the Registration Books. By the date fixed for redemption, due provision shall be made with the Paying Agent/Registrar for the payment of the required redemption price for the Certificates which are to be redeemed, plus accrued interest to the date fixed for redemption. If the notice of redemption is given, and if provision for payment is made, all as provided above, the Certificates, or the portions of the Certificates, which are to be redeemed, automatically shall be redeemed prior to their scheduled maturities, and shall not bear interest after the date fixed for their redemption, and shall not be regarded as outstanding except for the right of the Registered Owner to receive the redemption price plus accrued interest to the date fixed for redemption from the Paying Agent/Registrar out of the funds provided for payment. The Paying Agent/Registrar shall record in the Registration Books all redemptions of principal of the Certificates or any portion of the principal. If a portion of any Certificate shall be redeemed, one or more substitute Certificates having the same maturity date, bearing interest at the same rate, in any Authorized Denomination, at the written request of the Registered Owner, and in an aggregate principal amount equal to the unredeemed portion of the Certificates, will be issued to the Registered Owner upon the surrender for cancellation, at the expense of the City, all as provided in this Ordinance. In addition, the City shall cause the Paying Agent/Registrar to give notice of any redemption in the manner set forth in PART 5. The failure to cause notice to be given, however, or any defect in the notice, shall not affect the validity or effectiveness of the redemption. Unless the Paying Agent/Registrar has

received funds sufficient to pay the redemption price of the Certificates to be redeemed before giving of a notice of redemption, the notice of redemption may state the City may condition redemption on the receipt by the Paying Agent/Registrar of sufficient funds on or before the date fixed for the redemption, or on the satisfaction of any other prerequisites set forth in the notice of redemption. If a notice of conditional redemption is given and such prerequisites to the redemption and sufficient funds are not received, the notice shall be of no force and effect, the City shall not redeem the Certificates and the Paying Agent/Registrar shall give notice, in the manner in which the notice of redemption was given, that the Certificates have not been redeemed.

(D) If a notice of redemption is given and sufficient funds are not received for the payment of the required redemption price for the Certificates which are to be redeemed, the notice shall be of no force and effect, the City shall not redeem the Certificates, and the Paying Agent/Registrar shall give notice, in the manner in which the notice of redemption was given, that the Certificates have not been redeemed.

(E) Each redemption notice required by this Ordinance shall contain a description of the Certificates to be redeemed, including the complete name of the Certificates, the series, the date of issue, the interest rate, the maturity date, the CUSIP number, the amounts of the Certificates called for redemption, the date of redemption, the redemption price, the name of the Paying Agent/Registrar and the address at which the Certificate may be redeemed, including a contact person and telephone number. This notice may also state that the redemption is conditioned upon receipt of sufficient funds for the payment of the required redemption price for the Certificates which are to be redeemed by the date fixed for redemption. All redemption payments made by the Paying Agent/Registrar to the Registered Owner of the Certificates shall include CUSIP numbers relating to each amount paid to such Registered Owner.

PART 6. INTEREST

The Certificates shall bear interest at the rates per annum set forth in the Official Bid Form. The interest shall be payable to the Registered Owner of any Certificate in the manner provided and on the dates stated in the Official Bid Form. Interest shall be calculated on the basis of a 360-day year consisting of twelve 30-day months.

PART 7. ADDITIONAL CHARACTERISTICS OF THE CERTIFICATES

(A) The City shall keep, or cause to be kept, at the Designated Payment/Transfer Office, the Registration Books, and the Paying Agent/Registrar shall act as the registrar and transfer agent for the City to keep books or records and make the transfers and registrations under the reasonable regulations as the City and the Paying Agent/Registrar may prescribe; and the Paying Agent/Registrar shall make transfers and registrations as provided in this Ordinance. It shall be the duty of the Paying Agent/Registrar to obtain

from the Registered Owner and record in the Registration Books the address of the Registered Owner to which payments with respect to the Certificates shall be mailed, as provided in this Ordinance. The City, or its designee, shall have the right to inspect the Registration Books during regular business hours of the Paying Agent/Registrar, but otherwise the Paying Agent/Registrar shall keep the Registration Books confidential and, unless otherwise required by law, shall not permit their inspection by any other entity. Ownership of each Certificate may be transferred in the Registration Books only upon presentation and surrender of the Certificate to the Paying Agent/Registrar for transfer of registration and cancellation, together with proper written instruments of assignment, in form and with guarantee of signatures satisfactory to the Paying Agent/Registrar, evidencing the assignment of the Certificate, or any portion of the Certificate, in any Authorized Denomination, to the assignee or assignees, and the right of the assignee or assignees to have the Certificate or any portion of the Certificate registered in the name of the assignee or assignees. Upon the assignment and transfer of any Certificate, a new substitute obligation or Certificates shall be issued in exchange for the Certificate in the manner provided in this Ordinance.

(B) The entity in whose name any Certificate shall be registered in the Registration Books at any time shall be treated as the absolute owner of the Certificate for all purposes of this Ordinance, whether the Certificate shall be overdue, and the City and the Paying Agent/Registrar shall not be affected by any notice to the contrary; and payment of, or on account of, the principal of, premium, if any, and interest on any Certificate shall be made only to the Registered Owner. All payments shall be valid and effectual to satisfy and discharge the liability on the Certificate to the extent of the sum or sums so paid.

(C) The Paying Agent/Registrar shall act as the paying agent for paying the principal of, premium, if any, and interest on, the Certificates, and to act as the agent of the City to exchange or replace Certificates, all as provided in this Ordinance. The Paying Agent/Registrar shall keep proper records of all payments made by the City and the Paying Agent/Registrar with respect to the Certificates, and of all exchanges and replacements, as provided in this Ordinance.

(D) Each Certificate may be exchanged for fully registered Certificates as set forth in this Ordinance. Each Certificate issued and delivered pursuant to this Ordinance, to the extent of the unredeemed principal amount, may, upon surrender at the Designated Payment/Transfer Office, together with a written request duly executed by the Registered Owner or its assignee or assignees, or its or their duly authorized attorneys or representatives, with guarantee of signatures satisfactory to the Paying Agent/Registrar, at the option of the Registered Owner or its assignee or assignees, as appropriate, be exchanged for fully registered Certificates, without interest coupons, in the form prescribed in the Form of Certificate, in any Authorized Denomination (subject to the

requirement stated below that each substitute Certificate shall have a single stated maturity date), as requested in writing by the Registered Owner or its assignee or assignees, in an aggregate principal amount equal to the unredeemed principal amount of any Certificate or Certificates so surrendered, and payable to the appropriate Registered Owner, assignee, or assignees. If a portion of any Certificate is assigned and transferred, each Certificate issued in exchange shall have the same maturity date and bear interest at the same rate as the Certificate for which it is being exchanged. Each substitute Certificate shall bear a letter and/or number to distinguish it from each other Certificate. The Paying Agent/Registrar shall exchange or replace Certificates as provided in this Ordinance, and each fully registered Certificate delivered in exchange for or replacement of any Certificate or portion of a Certificate as permitted or required by any provision of this Ordinance shall constitute one of the Certificates for all purposes of this Ordinance, and may again be exchanged or replaced. Any Certificate delivered in exchange for or replacement of another Certificate before the first scheduled interest payment date on the Certificates (as stated on the face of the Certificate) shall be dated the same date, but each substitute Certificate delivered on or after the first scheduled interest payment date shall be dated the interest payment date preceding the date on which the substitute Certificate is delivered, unless the substitute Certificate is delivered on an interest payment date, in which case it shall be dated as of the date of delivery; however, if at the time of delivery of any substitute Certificate the interest on the Certificate for which it is being exchanged has not been paid, then the substitute Certificate shall be dated the date to which interest has been paid in full. On each substitute Certificate issued in exchange for or replacement of any Certificate issued under this Ordinance there shall be printed on the Certificate the Authentication Certificate. An authorized representative of the Paying Agent/Registrar shall, before the delivery of any substitute Certificate, date the substitute Certificate in the manner set forth above, and manually sign and date the Authentication Certificate, and no substitute Certificate shall be considered to be issued or outstanding unless the Authentication Certificate is executed. The Paying Agent/Registrar promptly shall cancel all Certificates surrendered for exchange or replacement. No additional ordinances, orders, or resolutions need be passed or adopted by Council or any other body or person to accomplish the exchange or replacement of any Certificate, and the Paying Agent/Registrar shall provide for the printing, execution, and delivery of the substitute Certificates in the manner prescribed in this Ordinance. Pursuant to Chapter 1206, the duty of exchange or replacement of any Certificate is imposed on the Paying Agent/Registrar, and, upon the execution of the Authentication Certificate, the exchanged or replaced obligation shall be valid, incontestable, and enforceable in the same manner and with the same effect as the Initial Certificate. Neither the City nor the Paying Agent/Registrar shall be required to transfer or exchange any Certificate selected for redemption, in whole or in part, within 45 calendar days of the date fixed for redemption; *provided, however*; the limitation of transfer shall not be applicable to an exchange by the Registered Owner of the uncalled principal of a Certificate.

(E) All Certificates issued in exchange or replacement of any other Certificate or portion of a Certificate (i) shall be issued in fully registered form, without interest coupons, with the principal of and interest on the Certificates to be payable only to the Registered Owners, (ii) may be redeemed prior to their scheduled maturities, (iii) may be transferred and assigned, (iv) may be exchanged for other Certificates, (v) shall have the characteristics, (vi) shall be signed and sealed, and (vii) the principal of and interest on the Certificates shall be payable, all as provided, and in the manner required or indicated in this Ordinance and the Bond Purchase Agreement.

(F) The City shall pay the Paying Agent/Registrar's reasonable and customary fees and charges for making transfers of Certificates, but the Registered Owner of any Certificate requesting the transfer shall pay any taxes or other governmental charges required for the transfer. The Registered Owner of any Certificate requesting any exchange shall pay the Paying Agent/Registrar's reasonable and standard or customary fees and charges for exchanging any Certificate or a portion of a Certificate, together with any required taxes or governmental charges, all as a condition precedent to the exercise of the privilege of exchange, except in the case of the exchange of an assigned and transferred Certificate or Certificates or any portion or portions in any Authorized Denomination, the fees and charges will be paid by the City. In addition, the City covenants with the Registered Owners of the Certificates that it will (i) pay the reasonable and standard or customary fees and charges of the Paying Agent/Registrar for its services with respect to the payment of the principal of and interest on the Certificates, when due, and (ii) pay the fees and charges of the Paying Agent/Registrar for services with respect to the transfer or registration of Certificates, and with respect to the exchange of Certificates solely to the extent stated above.

(G) An Authorized Representative is authorized to execute and deliver the Paying Agent/Registrar Agreement. The City covenants with the Registered Owners of the Certificates that at all times while the Certificates are outstanding the City will provide a competent and legally qualified bank, trust company, or other entity duly qualified and legally authorized to act as and perform the services of Paying Agent/Registrar for the Certificates under this Ordinance, and that the Paying Agent/Registrar will be one entity. The City reserves the right to, and may, at its option, change the Paying Agent/Registrar upon not less than 60 days' written notice to the Paying Agent/Registrar. In the event that the entity at any time acting as Paying Agent/Registrar (or its successor by merger, acquisition, or other method) should resign or otherwise stop acting as such, the City covenants that it will promptly appoint a competent and legally qualified national or state banking institution organized and doing business under the laws of the United States of America or of any state, authorized under the laws to exercise trust powers, subject to supervision or examination by federal or state authority, and whose qualifications substantially are similar to the previous Paying

Agent/Registrar to act as Paying Agent/Registrar under this Ordinance. Upon any change in the Paying Agent/Registrar, the previous Paying Agent/Registrar promptly shall transfer and deliver the Registration Books (or a copy of these Registration Books), along with all other pertinent books and records relating to the Certificates, to the new Paying Agent/Registrar designated and appointed by the City. Upon any change in the Paying Agent/Registrar, the City promptly will cause a written notice to be sent by the new Paying Agent/Registrar to each Registered Owner of the Certificates, by United States mail, first-class postage prepaid, which notice also shall give the address of the new Paying Agent/Registrar. By accepting the position and performing as such, each Paying Agent/Registrar shall be considered to have agreed to the provisions of this Ordinance, and a certified copy of this Ordinance shall be delivered to each Paying Agent/Registrar.

PART 8. FORM OF CERTIFICATES

The Certificates shall be signed with the manual or facsimile signatures of the Mayor and the City Clerk, and the seal of the City shall be affixed or impressed on the Certificates. The form of all Certificates, including the form of the Comptroller's Registration Certificate to accompany the Initial Certificate, the form of the Authentication Certificate, and the Form of Assignment to be printed on each Certificate, shall be, respectively, substantially in the form set forth in Exhibit A, with such appropriate variations, omissions, or insertions as are permitted or required by this Ordinance and the Official Bid Form.

PART 9. LEVY OF TAX; INTEREST AND SINKING FUND

(A) The Interest and Sinking Fund (which may include the designation or title by which a series of Certificates shall be known, as determined pursuant to PART 4(b) of this Ordinance) is created and it shall be established and maintained at an official depository of the City. The Interest and Sinking Fund shall be kept separate and apart from all other funds and accounts of the City, and shall be used only for paying the interest on and principal of the Certificates. All ad valorem taxes levied and collected for and on account of the Certificates shall be deposited, as collected, to the credit of the Interest and Sinking Fund. During each year while any Certificate is outstanding and unpaid, Council shall compute and ascertain the rate and amount of ad valorem tax, based on the latest approved tax rolls of the City, with full allowances being made for tax delinquencies and costs of tax collections, which will be sufficient to raise and produce the money required to pay the interest on the Certificates as the interest comes due, and to provide a sinking fund to pay the principal (including mandatory sinking fund redemption payments, if any) of the Certificates as the principal matures, but never less than 2% of the outstanding principal amount of the Certificates as a sinking fund each year. The rate and amount of ad valorem tax needed to fund this obligation is ordered to be and is hereby levied against all taxable property in the City for each year while any Certificate

439 is outstanding and unpaid, and the ad valorem tax shall be assessed and collected each
440 year and deposited to the credit of the Interest and Sinking Fund. The ad valorem taxes
441 necessary to pay the interest on and principal of the Certificates, as the interest comes
442 due, and the principal matures or comes due through operation of the mandatory sinking
443 fund redemption, if any, as provided in the Official Bid Form, are pledged for this
444 purpose, within the limit set by law. The City appropriates from current funds on hand,
445 and directs the transfer for deposit into the Interest and Sinking Fund moneys as may be
446 necessary to pay debt service on the Certificates scheduled to occur prior to receipt of
447 taxes levied to pay such debt service. Money in the Interest and Sinking Fund, at the
448 option of the City, may be invested in the securities or Certificates as permitted under
449 applicable law and the City's investment policy. Any securities or Certificates in which
450 money is invested shall be kept and held in trust for the benefit of the owners of the
451 Certificates and shall be sold and the proceeds of sale shall be timely applied to the
452 making of all payments required to be made from the Interest and Sinking Fund. Interest
453 and income derived from the investment of money in the Interest and Sinking Fund shall
454 be credited to the Interest and Sinking Fund.

455 (B) Should more than one series of Certificates be sold under authority of this
456 Ordinance, a separate interest and sinking fund will be created and maintained at an
457 official depository of the City to secure each series of Certificates.

458 **PART 10. REVENUES; APPLICABILITY OF CHAPTER 1208**

459 (A) The Certificates are additionally secured by and shall be payable from the
460 Surplus Revenues. The Surplus Revenues are pledged by the City pursuant to authority
461 of Chapter 363, specifically Section 363.135. The City shall promptly deposit the
462 Surplus Revenues on their receipt to the credit of the Interest and Sinking Fund created
463 pursuant to PART 9, to pay the principal and interest on the Certificates. The amount of
464 Surplus Revenues pledged to the payment of the Certificates shall not exceed \$1,000.

465 (B) Chapter 1208 applies to the issuance of the Certificates and the pledge of ad
466 valorem taxes and the Surplus Revenues granted by the City under PARTS 9 and 10 of
467 this Ordinance, and the pledge is valid, effective, and perfected. If Texas law is amended
468 at any time while the Certificates are outstanding and unpaid so that the pledge of the ad
469 valorem taxes and Surplus Revenues granted by the City is to be subject to the filing
470 requirements of Chapter 9, then to preserve to the registered owners of the Certificates
471 the perfection of the security interest in the pledge, the City agrees to take such measures
472 as it determines are reasonable and necessary under Texas law to comply with the
473 applicable provisions of Chapter 9 and enable a filing to perfect the security interest in
474 the pledge.

PART 11. DAMAGED, LOST, STOLEN OR DESTROYED CERTIFICATES

(A) In the event any outstanding Certificate is damaged, mutilated, lost, stolen, or destroyed, the Paying Agent/Registrar shall cause to be printed, executed, and delivered a new certificate of the same principal amount, maturity, and interest rate as the damaged, mutilated, lost, stolen, or destroyed Certificate in replacement for the Certificate in the manner provided in this Ordinance.

(B) Application for replacement of any damaged, mutilated, lost, stolen, or destroyed Certificate shall be made to the Paying Agent/Registrar. In every case of loss, theft, or destruction of a Certificate, the applicant for a replacement obligation shall furnish to the City and to the Paying Agent/Registrar the security or indemnity as may be required by them to save each of them harmless from any loss or damage with respect to the Certificate. Also, in every case of loss, theft, or destruction of a Certificate, the applicant shall furnish to the City and to the Paying Agent/Registrar evidence to their satisfaction of the loss, theft, or destruction of the Certificate. In every case of damage or mutilation of a Certificate, the applicant shall surrender to the Paying Agent/Registrar for cancellation the damaged or mutilated Certificate.

(C) Notwithstanding clauses (a) and (b), in the event any Certificate shall have matured, and there is no continuing default in the payment of the principal of, premium, if any, or interest on the Certificate, the City may authorize its payment (without surrender except in the case of a damaged or mutilated Certificate) instead of issuing a replacement Certificate, provided security or indemnity is furnished as above provided in this PART.

(D) Prior to the issuance of any replacement Certificate, the Paying Agent/Registrar shall charge the owner of the Certificate with all legal, printing, and other expenses in connection with the replacement. Every replacement Certificate issued pursuant to the provisions of this Ordinance by virtue of the fact that any Certificate is damaged, mutilated, lost, stolen, or destroyed shall constitute a contractual obligation of the City whether the damaged, mutilated, lost, stolen, or destroyed Certificate shall be found, or be enforceable by anyone, and shall be entitled to all the benefits of this Ordinance equally and proportionately with any and all other Certificates duly issued under this Ordinance.

(E) In accordance with Chapter 1206, this PART constitutes authority for the issuance of any such replacement Certificate without necessity of further action by Council or any other body or person, and the duty of the replacement of the Certificates is authorized and imposed on the Paying Agent/Registrar, subject to the conditions imposed by this PART, and the Paying Agent/Registrar shall authenticate and deliver the

Certificates in the form and manner and with the effect, as provided in PART 7(d) of this Ordinance for Certificates issued in exchange for other Certificates.

PART 12. SUBMISSION OF PROCEEDINGS TO ATTORNEY GENERAL

The Mayor, or his designee, and each Authorized Representative, is authorized to have control of the Certificates and all necessary records and proceedings pertaining to the Certificates pending their delivery and their investigation, examination and approval by the Texas Attorney General and their registration by the Comptroller. The City shall submit a single certificate of obligation to the Texas Attorney General, in the aggregate principal amount of the Certificates sold and containing the interest rates and schedule of principal payment dates, all as set forth in the Official Bid Form (the "Initial Certificate"). Upon registration of the Initial Certificate, the Comptroller (or a deputy designated in writing to act for the Comptroller) shall manually sign the Comptroller's Registration Certificate accompanying the Initial Certificate, and the seal of the Comptroller shall be impressed, or placed in facsimile, on the Initial Certificate. The Initial Certificate shall be numbered T-1. After registration by the Comptroller, delivery of the Certificates shall be made to the Purchasers, under and subject to the general supervision and direction of the Mayor or an Authorized Representative, against receipt by the City of all amounts due to the City under the terms of sale, and the Initial Certificate shall be cancelled. Council authorizes the payment of the fee of the Office of the Attorney General of the State of Texas for the examination of the proceedings relating to the issuance of the Certificates, in the amount determined in accordance with the provisions of Section 1202.004, Texas Government Code.

PART 13. SALE OF CERTIFICATES; OFFICIAL STATEMENT

(A) The Certificates shall be sold to the Purchasers at the price set forth in the Official Bid Form, and delivery of the Certificates to the Purchasers shall be made upon receipt of payment in accordance with the terms of the Official Bid Form. An Authorized Representative is authorized and directed to execute the Official Bid Form on behalf of the City, and the Mayor, Mayor Pro Tem, City Manager, Chief Financial Officer, City Clerk and all other officials, agents and representatives of the City are authorized to execute and deliver such agreements, certificates, instruments and other documents, and do any and all things necessary or desirable to satisfy the conditions set out in the documents, to provide for the issuance and delivery of the Certificates.

(B) Council ratifies, authorizes and approves, in connection with the sale of the Certificates, the preparation and distribution of the Preliminary Official Statement and a final Official Statement, substantially in the form of the Preliminary Official Statement, containing additional information and amendments as may be necessary to conform to the terms of the Certificates, this Ordinance and the Official Bid Form, and the Preliminary

Official Statement is deemed final as of its date within the meaning and for the purposes of paragraph (b)(1) of the Rule. An Authorized Representative is authorized to approve such amendments and supplements to the Official Statement as either of them shall deem necessary or appropriate. The Mayor and City Clerk are authorized to execute the final Official Statement by manual, facsimile or electronic signature and/or to deliver a certificate pertaining to the final Official Statement as prescribed in the Official Statement or in the Official Bid Form, dated as of the date of payment for and delivery of the Certificates.

(C) The Mayor, Mayor Pro Tem, City Manager, City Clerk, Chief Financial Officer and all other officials, agents and representatives of the City are authorized to take actions as any officer, official, agent or representative shall approve in seeking ratings on the Certificates from one or more nationally recognized statistical ratings organizations, or any confirmation of ratings issued by a rating agency, and these actions are ratified and confirmed.

(D) Proceeds from the sale of the Certificates shall be disbursed in the amounts and for the purposes set forth in the closing letter of instructions. An Authorized Representative may provide for the establishment of any fund, account or subaccount as deemed necessary or appropriate for the safekeeping and administration of proceeds from the sale of the Certificates pending their disbursement for authorized purposes.

(E) An Authorized Representative shall not execute the Official Bid Form unless the each of the Purchasers has confirmed to an Authorized Representative that either it has made disclosure filings to the Texas Ethics Commission in accordance with Section 2252.908, Texas Government Code or is exempt from making filings under Section 2252.908(c)(4), Texas Government Code. Within 30 days of receipt of the execution of the Official Bid Form, disclosure filings received from any of the Purchasers will be acknowledged by the City in accordance with the rules of the Texas Ethics Commission.

PART 14. COVENANTS TO MAINTAIN TAX EXEMPT STATUS

The City covenants to refrain from any action which would adversely affect, or to take any action to assure, the treatment of the Certificates as obligations described in section 103 of the Code, the interest on which is not includable in the "gross income" of the holder for purposes of federal income taxation. The City covenants as follows:

(A) to take any action to assure that no more than 10 percent of the proceeds of the Certificates or the projects financed therewith (less amounts deposited to a reserve fund, if any) are used for any "private business use", as defined in section 141(b)(6) of the Code or, if more than 10 percent of the proceeds are so used, that amounts, whether or not received by the City, with respect to such

private business use, do not, under the terms of this Ordinance or any underlying arrangement, directly or indirectly, secure or provide for the payment of more than 10 percent of the debt service on the Certificates, in contravention of section 141(b)(2) of the Code;

(B) to take any action to assure that in the event that the "private business use" described in subsection (a) hereof exceeds 5 percent of the proceeds of the Certificates or the projects financed therewith (less amounts deposited into a reserve fund, if any) then the amount in excess of 5 percent is used for a "private business use" which is "related" and not "disproportionate", within the meaning of section 141(b)(3) of the Code, to the governmental use;

(C) to take any action to assure that no amount which is greater than the lesser of \$5,000,000, or 5 percent of the proceeds of the Certificates (less amounts deposited into a reserve fund, if any), is directly or indirectly used to finance loans to persons, other than state or local governmental units, in contravention of section 141(c) of the Code;

(D) to refrain from taking any action which would otherwise result in the Certificates being treated as "private activity bonds" within the meaning of section 141(a) of the Code;

(E) to refrain from taking any action that would result in the Certificates being "federally guaranteed" within the meaning of section 149(b) of the Code;

(F) to refrain from using any portion of the proceeds of the Certificates, directly or indirectly, to acquire or to replace funds which were used, directly or indirectly, to acquire investment property (as defined in section 148(b)(2) of the Code) which produces a materially higher yield over the term of the Certificates, other than investment property acquired with --

(1) proceeds of the Certificates invested for a reasonable temporary period, until such proceeds are needed for the purpose for which the Certificates are issued,

(2) amounts invested in a bona fide debt service fund, within the meaning of section 1.148-1(b) of the Treasury Regulations, and

(3) amounts deposited in any reasonably required reserve or replacement fund to the extent such amounts do not exceed 10 percent of the proceeds of the Certificates;

(G) to otherwise restrict the use of the proceeds of the Certificates or amounts treated as proceeds of the Certificates, as may be necessary, so that the Certificates do not otherwise contravene the requirements of section 148 of the Code (relating to arbitrage);

(H) to refrain from using the proceeds of the Certificates or the proceeds of any prior bonds to pay debt service on another issue more than ninety (90) days after the issuance of the Certificates in contravention of section 149(d) of the Code (relating to advance refundings); and

(I) to pay to the United States of America at least once during each five-year period (beginning on the date of delivery of the Certificates) an amount that is at least equal to 90 percent of the "excess earnings", within the meaning of section 148(f) of the Code, and to pay to the United States of America, not later than 60 days after the Certificates have been paid in full, 100 percent of the amount then required to be paid as a result of Excess Earnings under section 148(f) of the Code.

The City understands that the term "proceeds" includes "disposition proceeds" as defined in the Treasury Regulations and, in the case of a refunding bond, transferred proceeds (if any) and proceeds of the refunded bonds expended prior to the date of the issuance of the Certificates. It is the understanding of the City that the covenants contained herein are intended to assure compliance with the Code and any regulations or rulings promulgated by the U.S. Department of the Treasury pursuant thereto. In the event that regulations or rulings are hereafter promulgated which modify or expand provisions of the Code, as applicable to the Certificates, the City will not be required to comply with any covenant contained herein to the extent that such failure to comply, in the opinion of nationally-recognized bond counsel, will not adversely affect the exemption from federal income taxation of interest on the Certificates under section 103 of the Code. In the event that regulations or rulings are hereafter promulgated which impose additional requirements which are applicable to the Certificates, the City agrees to comply with the additional requirements to the extent necessary, in the opinion of nationally-recognized bond counsel, to preserve the exemption from federal income taxation of interest on the Certificates under section 103 of the Code. In furtherance of the foregoing, the Mayor, the City Manager, any Assistant City Manager, the Chief Financial Officer, any Deputy Financial Officer and the City Treasurer may execute any certificates or other reports required by the Code and make such elections, on behalf of the City, which may be permitted by the Code as are consistent with the purpose for the issuance of the Certificates. In order to facilitate compliance with the above clause (i), a "Rebate Fund" is hereby established by the City for the sole benefit of the United States of America, and such Rebate Fund shall not be subject to the claim of any other person, including without limitation the registered owners of the Certificates. The Rebate Fund is established for the additional purpose of compliance with section 148 of the Code.

660
661 The City covenants to account for on its books and records the expenditure of
662 proceeds from the sale of the Certificates and any investment earnings thereon to be used
663 to finance the Projects described in Schedule I by allocating proceeds to expenditures
664 within eighteen (18) months of the later of the date that (a) the expenditure on a Project is
665 made or (b) the acquisition of the Project is completed. The City shall not expend such
666 proceeds or investment earnings more than 60 days after the later of (a) the fifth
667 anniversary of the date of delivery of the Certificates or (b) the date the Certificates are
668 retired, unless the City obtains an opinion of nationally-recognized bond counsel
669 substantially to the effect that the expenditure will not adversely affect the tax-exempt
670 status of the Certificates. The City shall not be obligated to comply with this covenant if
671 it obtains an opinion of nationally-recognized bond counsel to the effect that the failure to
672 comply will not adversely affect the excludability for federal income tax purposes from
673 gross income of the interest.

674
675 The City covenants that the property financed or refinanced with the proceeds of
676 the Certificates will not be sold or otherwise disposed in a transaction resulting in the
677 receipt by the City of cash or other compensation, unless the City obtains an opinion of
678 nationally-recognized bond counsel substantially to the effect that such sale or other
679 disposition will not adversely affect the tax-exempt status of the Certificates. The portion
680 of the property comprising personal property and disposed of in the ordinary course of
681 business shall not be treated as a transaction resulting in the receipt of cash or other
682 compensation. The City shall not be obligated to comply with this covenant if it obtains
683 an opinion of nationally-recognized bond counsel to the effect that the failure to comply
684 will not adversely affect the excludability for federal income tax purposes from gross
685 income of the interest.

686 **PART 15. CONTINUING DISCLOSURE OBLIGATION**

687 **(A) *Annual Reports.***

688 (1) The City shall provide annually to the MSRB, (A) within six months
689 after the end of each fiscal year of the City, financial information and operating data
690 with respect to the City of the general type included in the final Official Statement
691 authorized by PART 13 of this Ordinance, being information of the type described
692 in the final Official Statement, including financial statements of the City if audited
693 financial statements of the City are then available, and (B) if not provided as part
694 such financial information and operating data, audited financial statements of the
695 City, when and if available. Any financial statements to be provided shall be (x)
696 prepared in accordance with the accounting principles described in the final Official
697 Statement, or such other accounting principles as the City may be required to employ
698 from time to time pursuant to state law or regulation, and in substantially the form

699 included in the final Official Statement, and (y) audited, if the City commissions an
700 audit of its financial statements and the audit is completed within the period during
701 which they must be provided. If the audit of financial statements is not complete
702 within 12 months after any fiscal year end, then the City shall file unaudited financial
703 statements within the 12-month period and audited financial statements for the
704 applicable fiscal year, when and if the audit report on the financial statements
705 becomes available.

706 (2) If the City changes its fiscal year, it will notify the MSRB of the
707 change (and of the date of the new fiscal year end) before the next date the City
708 would be required to provide financial information and operating data pursuant to
709 this PART.

710 (3) The financial information and operating data to be provided pursuant
711 to this PART may be set forth in full in one or more documents or may be included
712 by specific reference to any document (including an official statement or other
713 offering document) available to the public on the MSRB's website or filed with the
714 SEC. Filings shall be made electronically, accompanied by identifying information
715 as prescribed by the MSRB.

716 (B) *Disclosure Event Notices.* The City shall notify the MSRB in an electronic
717 format prescribed by the MSRB, in a timely manner not in excess of 10 Business Days
718 after the occurrence of the event, of any of the following events with respect to the
719 Certificates:

- 720 1. Principal and interest payment delinquencies;
- 721 2. Non-payment related defaults, if material;
- 722 3. Unscheduled draws on debt service reserves reflecting financial
723 difficulties;
- 724 4. Unscheduled draws on credit enhancements reflecting financial
725 difficulties;
- 726 5. Substitution of credit or liquidity providers, or their failure to perform;
- 727 6. Adverse tax opinions, the issuance by the Internal Revenue Service of
728 proposed or final determinations of taxability, Notices of Proposed Issue (IRS
729 Form 5701-TEB) or other material notices or determinations with respect to the tax
730 status of the Certificates, or other material events affecting the tax status of the
731 Certificates;
- 732 7. Modifications to rights of holders of the Certificates, if material;
- 733 8. Certificate calls, if material, and tender offers;

- 734 9. Defeasances;
- 735 10. Release, substitution, or sale of property securing repayment of the
- 736 Certificates, if material;
- 737 11. Rating changes;
- 738 12. Bankruptcy, insolvency, receivership or similar event of the City;
- 739 13. The consummation of a merger, consolidation, or acquisition
- 740 involving the City or the sale of all or substantially all of the assets of the City,
- 741 other than in the ordinary course of business, the entry into a definitive agreement
- 742 to undertake such an action or the termination of a definitive agreement relating to
- 743 any such actions, other than pursuant to its terms, if material;
- 744 14. Appointment of a successor Paying Agent/Registrar or change in the
- 745 name of the Paying Agent/Registrar, if material;
- 746 15. Incurrence of a Financial Obligation of the Obligated Person, if
- 747 material, or agreement to covenants, events of default, remedies, priority rights, or
- 748 other similar terms of a Financial Obligation of the Obligated Person, any of which
- 749 affect security holders, if material; and
- 750 16. Default, event of acceleration, termination event, modification of
- 751 terms, or other similar event under the terms of a Financial Obligation of the
- 752 Obligated Person, and which reflect financial difficulties.

753 The City shall notify the MSRB in an electronic format prescribed by the MSRB,

754 in a timely manner, of any failure by the City to provide financial information or

755 operating data in accordance with subsection (a) of this PART by the time required by

756 subsection (a).

757 As used in clause (xii) above, the phrase "bankruptcy, insolvency, receivership or

758 similar event" means the appointment of a receiver, fiscal agent or similar officer for the

759 City in a proceeding under the U.S. Bankruptcy Code or in any other proceeding under

760 state or federal law in which a court or governmental authority has assumed jurisdiction

761 over substantially all of the assets or business of the City, or if jurisdiction has been

762 assumed by leaving Council and officials or officers of the City in possession but subject

763 to the supervision and orders of a court or governmental authority, or the entry of an

764 order confirming a plan of reorganization, arrangement or liquidation by a court or

765 governmental authority having supervision or jurisdiction over substantially all of the

766 assets or business of the City.

767

768 As used in clauses (xv) and (xvi) above, the term "Financial Obligation" means: (i)

769 a debt obligation; (ii) a derivative instrument entered into in connection with, or pledged

770 as security or a source of payment for, an existing or planned debt obligation; or (iii) a

771 guarantee of (i) or (ii); however, the term Financial Obligation shall not include
772 Municipal Securities as to which a final official statement has been provided to the
773 MSRB consistent with the Rule; the term "Municipal Securities" means securities which
774 are direct obligations of, or obligations guaranteed as to principal or interest by, a state or
775 any political subdivision thereof, or any agency or instrumentality of a state or any
776 political subdivision thereof, or any municipal corporate instrumentality of one or more
777 states and any other Municipal Securities described by Section 3(a)(29) of the Securities
778 Exchange Act of 1934, as the same may be amended from time to time; and the term
779 "Obligated Person" means the City.

780
781 (C) *Limitations, Disclaimers, and Amendments.* The City shall be obligated to
782 observe and perform the covenants named in this PART for only so long as the City
783 remains an "obligated person" with respect to the Certificates within the meaning of the
784 Rule, except that the City will give written notice of any deposit made in accordance with
785 this Ordinance, or applicable law, that causes any Certificate no longer to be outstanding.

786 The provisions of this PART are for the sole benefit of the holders and beneficial
787 owners of the Certificates, and nothing in this PART, express or implied, shall give any
788 benefit or any legal or equitable right, remedy, or claim to any other person. The City
789 undertakes to provide only the financial information, operating data, financial statements,
790 and notices which it has expressly agreed to provide pursuant to this PART and does not
791 undertake to provide any other information that may be relevant or material to a complete
792 presentation of the City's financial results, condition, or prospects or to update any
793 information provided in accordance with this PART or otherwise, except as expressly
794 provided in this Ordinance. The City does not make any representation or warranty
795 concerning the information or its usefulness to a decision to invest in or sell Certificates
796 at any future date.

797 UNDER NO CIRCUMSTANCES SHALL THE CITY BE LIABLE TO THE
798 HOLDER OR BENEFICIAL OWNER OF ANY OBLIGATION OR ANY OTHER
799 PERSON, IN CONTRACT OR TORT, FOR DAMAGES RESULTING IN WHOLE OR
800 IN PART FROM ANY BREACH BY THE CITY, WHETHER NEGLIGENT OR
801 WITHOUT FAULT ON ITS PART, OF ANY COVENANT SPECIFIED IN THIS
802 PART, BUT EVERY RIGHT AND REMEDY OF ANY PERSON, IN CONTRACT OR
803 TORT, FOR OR ON ACCOUNT OF ANY BREACH SHALL BE LIMITED TO AN
804 ACTION FOR MANDAMUS OR SPECIFIC PERFORMANCE.

805 No default by the City in observing or performing its obligations under this PART
806 shall comprise a breach of or default under this Ordinance for purposes of any other
807 provision of this Ordinance. Nothing in this PART is intended or shall act to disclaim,
808 waive, or otherwise limit the duties of the City under federal and state securities laws.

809 The provisions of this PART may be amended by the City from time to time to
810 adapt to changed circumstances that arise from a change in legal requirements, a change
811 in law, or a change in the identity, nature, status, or type of operations of the City, but
812 only if (1) the provisions of this PART, as amended, would have permitted an
813 underwriter to purchase or sell Certificates in the primary offering of the Certificates in
814 compliance with the Rule, taking into account any amendments or interpretations of the
815 Rule since the offering as well as the changed circumstances and (2) either (a) the holders
816 of a majority in aggregate principal amount (or any greater amount required by any other
817 provision of this Ordinance that authorizes an amendment) of the outstanding Certificates
818 consent to the amendment or (b) a person that is unaffiliated with the City (such as
819 nationally-recognized bond counsel) determines that the amendment will not materially
820 impair the interest of the holders and beneficial owners of the Certificates. If the City
821 amends the provisions of this PART, it shall include with the next financial information
822 and operating data provided in accordance with subsection (a) of this PART an
823 explanation, in narrative form, of the reason for the amendment and of the impact of any
824 change in the type of financial information or operating data so provided. The City may
825 also amend or repeal the provisions of this continuing disclosure agreement if the SEC
826 amends or repeals the applicable provision of the Rule or a court of final jurisdiction
827 enters judgment that the provisions of the Rule are invalid, but only if and to the extent
828 that the provisions of this sentence would not prevent an underwriter from lawfully
829 purchasing or selling Certificates in the primary offering of the Certificates. Should the
830 Rule be amended to obligate the City to make filings with or provide notices to entities
831 other than the MSRB, the City agrees to undertake such obligation in accordance with the
832 Rule as amended.

833 **PART 16. DTC REGISTRATION**

834 The Certificates initially shall be issued and delivered in the manner that no
835 physical distribution of the Certificates will be made to the public, and DTC initially will
836 act as depository for the Certificates. DTC has represented that it is a limited purpose
837 trust company incorporated under the laws of the State of New York, a member of the
838 Federal Reserve System, a “clearing corporation” within the meaning of the New York
839 Uniform Commercial Code, and a “clearing agency” registered under Section 17A of the
840 Securities Exchange Act of 1934, as amended, and the City accepts, but in no way
841 verifies, the representations of DTC. The Certificates initially authorized by this
842 Ordinance intended to be held by DTC shall be delivered to and registered in the name of
843 Cede & Co., the nominee of DTC. It is expected that DTC will hold the Certificates on
844 behalf of the Purchasers and their participants. So long as each Certificate is registered in
845 the name of Cede & Co., the Paying Agent/Registrar shall treat and deal with DTC the
846 same in all respects as if it were the actual and beneficial owner. It is expected that DTC
847 will maintain a book-entry system, which will identify ownership of the Certificates in

Authorized Denominations, with transfers of ownership being effected on the records of DTC and its participants pursuant to rules and regulations established by them, and that the Certificates initially deposited with DTC shall be immobilized and not be further exchanged for substitute Certificates except as set forth in this Ordinance. The City and the Paying Agent/Registrar are not responsible or liable for any functions of DTC, will not be responsible for paying any fees or charges with respect to its services, will not be responsible or liable for maintaining, supervising, or reviewing the records of DTC or its participants, or protecting any interests or rights of the beneficial owners of the Certificates. It shall be the duty of the DTC Participants, as defined in the Official Statement, to make all arrangements with DTC to establish this book-entry system, the beneficial ownership of the Certificates, and the method of paying the fees and charges of DTC. The City does not represent, nor does it in any way covenant that the initial book-entry system established with DTC will be maintained in the future. Notwithstanding the initial establishment of the foregoing book-entry system with DTC, if for any reason any of the originally delivered Certificates is duly filed with the Paying Agent/Registrar with proper request for transfer and substitution, as provided for in this Ordinance, substitute Certificates will be duly delivered as provided in this Ordinance, and there will be no assurance or representation that any book-entry system will be maintained for the Certificates. In connection with the initial establishment of the foregoing book-entry system with DTC, the City has executed a "Blanket Letter of Representations" prepared by DTC in order to implement the book-entry system described above.

PART 17. DEFEASANCE

(A) *Defeased Certificates.* Any Certificate will be treated as a Defeased Certificate, except to the extent provided in subsection (d) of this PART, when payment of the principal of the Certificate, plus interest to the due date (whether the due date be by reason of maturity, redemption or otherwise) either (i) shall have been made or caused to be made in accordance with the terms of this Ordinance, or (ii) shall have been provided for on or before the due date by irrevocably depositing with or making available to the Paying Agent/Registrar or any commercial bank or trust company authorized to serve as escrow agent for the Certificates in accordance with a Future Escrow Agreement for the payment of the Certificate (1) lawful money of the United States of America sufficient to make the payment or (2) Defeasance Securities to mature as to principal and interest in the amounts and at the time as will ensure the availability, without reinvestment, of sufficient money to provide for the payment, and when proper arrangements have been made by the City with the Paying Agent/Registrar for the payment of its services until all Defeased Certificates shall have become due and payable. There shall be delivered to the Paying Agent/Registrar a certificate of a qualified financial professional or a report from a firm of certified public accountants evidencing the sufficiency of the deposit made pursuant to clause (ii) above. The Paying Agent/Registrar shall also receive an opinion

of bond counsel acceptable to the City that reflects this payment does not adversely affect the exclusion under the Code of interest on the Defeased Certificates from the gross income of the holders for federal income taxation purposes. At the time as a Certificate shall be considered to be a Defeased Certificate, the Certificate and the interest on that Certificate shall no longer be secured by, payable from, or entitled to the benefits of the ad valorem taxes levied and pledged as provided in this Ordinance, and the principal and interest shall be payable solely from the money or Defeasance Securities.

(B) *Investment in Defeasance Securities.* Any funds deposited with the Paying Agent/Registrar may at the written direction of the City be invested in Defeasance Securities, maturing in the amounts and times as set forth in this Ordinance, and all income from these Defeasance Securities received by the Paying Agent/Registrar that is not required for the payment of the Certificates and interest, with respect to which money has been deposited, shall be turned over to the City, or deposited as directed in writing by the City. Any Future Escrow Agreement pursuant to which the money and/or Defeasance Securities are held for the payment of Defeased Certificates may contain provisions permitting the investment or reinvestment of the moneys in Defeasance Securities or the substitution of other Defeasance Securities upon the satisfaction of the requirements described in subsections (a) (i) or (ii) of this PART. All income from the Defeasance Securities received by the Paying Agent/Registrar which is not required for the payment of the Defeased Certificates, with respect to which money has been so deposited, shall be remitted to the City or deposited as directed in writing by the City. The Paying Agent/Registrar shall not be liable for any loss pertaining to an investment executed in accordance with written instructions from the City.

(C) *Paying Agent/Registrar Services.* Until all Defeased Certificates shall have become due and payable, the Paying Agent/Registrar shall perform the services of Paying Agent/Registrar for the Defeased Certificates as if they had not been defeased, and the City shall make proper arrangements to provide and pay for the services as required by this Ordinance.

(D) *Selection of Certificates for Defeasance.* In the event that the City elects to defease less than all of the principal amount of Certificates of a maturity, the Paying Agent/Registrar shall select, or cause to be selected, the amount of Certificates by the random method as it considers fair and appropriate.

PART 18. DEFAULT AND REMEDIES

(A) *Events of Default.* Each of the following occurrences or events is an Event of Default:

922 (1) the failure to pay the principal of or interest on any Certificate when it
923 becomes due and payable; or

924 (2) default in the performance or observance of any other covenant,
925 agreement or obligation of the City, the failure to perform which materially,
926 adversely affects the rights of the Registered Owners of the Certificates, including
927 their prospect or ability to be repaid in accordance with this Ordinance, and the
928 continuation for a period of 60 days after notice of the default is given by any
929 Registered Owner to the City.

930 (B) *Remedies for Default.*

931 (1) When any Event of Default occurs, any Registered Owner or the
932 Registered Owner's authorized representative, including a trustee or trustees, may
933 proceed against the City, or any official, officer or employee of the City in their
934 official capacity, for the purpose of protecting and enforcing the rights of the
935 Registered Owners under this Ordinance, by mandamus or other suit, action or
936 special proceeding in equity or at law, in any court of competent jurisdiction, for
937 any relief permitted by law, including the specific performance of any covenant or
938 agreement contained in this Ordinance, or to enjoin any act or thing that may be
939 unlawful or in violation of any right of the Registered Owners or any combination
940 of remedies only as authorized by law.

941 (2) All default proceedings shall be instituted and maintained for the
942 equal benefit of all Registered Owners of outstanding Certificates.

943 (C) *Remedies Not Exclusive.*

944 (1) No remedy in this Ordinance is exclusive of any other available
945 remedy, but each remedy shall be cumulative and shall be in addition to every other
946 remedy given in this Ordinance or under the Certificates; however, there is no right
947 to accelerate the debt evidenced by the Certificates.

948 (2) The exercise of any remedy in this Ordinance shall not be considered
949 a waiver of any other available remedy.

950 (3) By accepting the delivery of a Certificate authorized under this
951 Ordinance, the Registered Owner agrees that the certifications required to effect any
952 covenants or representations contained in this Ordinance do not and shall never
953 constitute or give rise to a personal or pecuniary liability or charge against the
954 officers or employees of the City or Council.

(4) None of the members of Council, nor any other official or officer, agent, or employee of the City, shall be charged personally by the Registered Owners with any liability, or be held personally liable to the Registered Owners under any term or provision of this Ordinance, or because of any Event of Default or alleged Event of Default under this Ordinance.

PART 19. OFFICIALS MAY ACT ON BEHALF OF THE CITY

(A) The Mayor, the Mayor Pro Tem, the City Clerk, the City Manager, any Assistant City Manager, the Chief Financial Officer, or any Deputy Chief Financial Officer, and all other officers, employees, and agents of the City, and each of them, shall be authorized, empowered, and directed to do and perform all acts and things and to execute, acknowledge, and deliver in the name and under the seal and on behalf of the City all instruments as may be necessary or desirable in order to carry out the terms and provisions of this Ordinance, the Certificates, the Official Bid Form, the offering documents prepared in connection with the sale of the Certificates, or the Paying Agent/Registrar Agreement. In case any officer whose signature appears on any Certificate shall stop being the officer before the delivery of the Certificate, the signature shall nevertheless be valid and sufficient for all purposes as if he or she had remained in office until the delivery.

(B) The Mayor, the Mayor Pro Tem and any Authorized Representative are each authorized to make or approve such revisions, additions, deletions, and variations to this Ordinance that, in their judgment and in the opinion of Bond Counsel to the City, may be necessary or convenient to carry out or assist in carrying out the purposes of this Ordinance, the Official Bid Form, the Paying Agent/Registrar Agreement, the Preliminary Official Statement and the final Official Statement or as may be required for approval of the Certificates by the Attorney General of Texas.

(C) Any duty, responsibility, privilege, power or authority conferred by this Ordinance upon an officer shall extend to an individual who occupies such office in an interim, acting or provisional capacity.

PART 20. RULES OF CONSTRUCTION

For all purposes of this Ordinance, unless the context requires otherwise, all references to designated PARTS and other subdivisions are to the PARTS and other subdivisions of this Ordinance. Except where the context otherwise requires, terms defined in this Ordinance to impart the singular number shall be considered to include the plural number and vice versa. References to any named person shall mean that party and his or her successors and assigns. Any duty, responsibility, privilege, power or authority conferred by this Ordinance upon an official or officer shall extend to an individual who

occupies such office in an interim, acting or provisional capacity. References to any constitutional, statutory or regulatory provision means the provision as it exists on the date this Ordinance is adopted by the City. Any reference to the payment of principal in this Ordinance shall include the payment of any mandatory sinking fund redemption payments as described in this Ordinance. Any reference to “Form of Certificate” refers to the form of the Certificates in Exhibit A to this Ordinance. The titles and headings of the PARTS and subsections of this Ordinance have been inserted for convenience of reference only and are not a part of this Ordinance and shall not in any way modify or restrict any of its terms or provisions.

PART 21. CONFLICTING ORDINANCES REPEALED.

All ordinances and resolutions or parts in conflict with this Ordinance are repealed.

PART 22. IMMEDIATE EFFECT.

In accordance with the provisions of Section 1201.028, Texas Government Code, this Ordinance is effective immediately upon its adoption by Council.

THE PRINCIPAL OF AND INTEREST ON this Certificate are payable in lawful money of the United States of America, without exchange or collection charges. The principal of this Certificate shall be paid to the registered owner hereof upon presentation and surrender of this Certificate at maturity or redemption prior to maturity at the designated corporate trust office in Dallas, Texas (the “Designated Payment/Transfer Office”) of U.S. Bank National Association, which is the “Paying Agent/Registrar” for this Certificate. The payment of interest on this Certificate shall be made by the Paying Agent/Registrar to the registered owner hereof as shown by the Registration Books kept by the Paying Agent/Registrar at the close of business on the record date, which is the 15th day of the month next preceding such interest payment date by check, dated as of such interest payment date, drawn by the Paying Agent/Registrar on, and payable solely from, funds of the City required to be on deposit with the Paying Agent/Registrar for such purpose as hereinafter provided; and such check shall be sent by the Paying Agent/Registrar by United States mail, first-class postage prepaid, on each such interest payment date, to the registered owner hereof at its address as it appears on the Registration Books kept by the Paying Agent/Registrar, as hereinafter described. Any accrued interest due at maturity or upon redemption of this Certificate prior to maturity as provided herein shall be paid to the registered owner upon presentation and

surrender of this Certificate for redemption and payment at the Designated Payment/Transfer Office of the Paying Agent/Registrar. The City covenants with the registered owner of this Certificate that no later than each principal payment and/or interest payment date for this Certificate it will make available to the Paying Agent/Registrar from the Interest and Sinking Fund as defined by the ordinance authorizing the Certificates (the "Ordinance") the amounts required to provide for the payment, in immediately available funds, of all principal of, premium, if any, and interest on the Certificates, when due.

IN THE EVENT OF A NON-PAYMENT of interest on a scheduled payment date, and for thirty (30) days thereafter, a new record date for such interest payment (a "Special Record Date") will be established by the Paying Agent/Registrar, if and when funds for the payment of such interest have been received from the City. Notice of the Special Record Date and of the scheduled payment date of the past due interest ("Special Payment Date," which shall be fifteen (15) days after the Special Record Date) shall be sent at least five (5) business days prior to the Special Record Date by United States mail, first-class postage prepaid, to the address of each registered owner of a Certificate appearing on the registration books of the Paying Agent/Registrar at the close of business on the last business day next preceding the date of mailing of such notice.

IF THE DATE for the payment of the principal of, premium, if any, or interest on this Certificate shall be a Saturday, Sunday, a legal holiday, or a day on which banking institutions in the city where the Designated Payment/Transfer Office of the Paying Agent/Registrar is located are authorized by law or executive order to close, then the date for such payment shall be the next succeeding day which is not such a Saturday, Sunday, legal holiday, or day on which banking institutions are authorized to close; and payment on such date shall have the same force and effect as if made on the original date payment was due. Notwithstanding the foregoing, during any period in which ownership of the Certificates is determined only by a book entry at a securities depository for the Certificates, any payment to the securities depository, or its nominee or registered assigns, shall be made in accordance with existing arrangements between the City and the securities depository.

THIS CERTIFICATE is one of a series of Certificates of like tenor and effect except as to number, principal amount, interest rate, maturity and option of redemption, dated as of the Dated Date specified above, authorized in accordance with the Constitution and laws of the State of Texas in the aggregate principal amount of \$43,930,000, for the purpose of providing funds with which to pay contractual obligations to be incurred by the City, to-wit: making and acquiring various public improvements for the City, as described in the Ordinance, and the payment of fiscal, engineering and legal fees incurred in connection therewith.

ON SEPTEMBER 1, 2031, or on any date thereafter, the Certificates of this series maturing on September 1, 2032, and thereafter may be redeemed prior to their scheduled maturities, at the option of the City, in whole, or in part, at a price equal to the principal amount thereof, without premium, plus accrued interest to the date fixed for redemption. The years of maturity of the Certificates called for redemption at the option of the City prior to stated maturity shall be selected by the City. The Certificates or portions thereof redeemed within a maturity shall be selected by lot or other customary random selection method by the Paying Agent/Registrar; *provided*, that during any period in which ownership of the Certificates is determined only by a book entry at a securities depository for the Certificates, if fewer than all of the Certificates of the same maturity and bearing the same interest rate are to be redeemed, the particular Certificates of such maturity

and bearing such interest rate shall be selected in accordance with the arrangements between the City and the securities depository.

AT LEAST thirty (30) days prior to the date fixed for any redemption, a written notice of redemption shall be given to the registered owner of each Certificate or a portion thereof being called for redemption by depositing such notice in the United States mail, first class postage prepaid, addressed to each such registered owner at his address shown on the Registration Books of the Paying Agent/Registrar. By the date fixed for any redemption due provision shall be made by the City with the Paying Agent/Registrar for the payment of the required redemption price for this Certificate or the portion hereof which is to be so redeemed, plus accrued interest thereon to the date fixed for redemption. If notice of redemption is given, and if due provision for such payment is made, all as provided above, this Certificate, or the portion hereof which is to be so redeemed, thereby automatically shall be redeemed prior to its scheduled maturity, and shall not bear interest after the date fixed for its redemption, and shall not be regarded as being outstanding except for the right of the registered owner to receive the redemption price plus accrued interest to the date fixed for redemption from the Paying Agent/Registrar out of the funds provided for payment. The Paying Agent/Registrar shall record in the Registration Books all redemptions of principal of this Certificate or any portion hereof. If a portion of any Certificate shall be redeemed, a substitute Certificate or Certificates having the same maturity date, bearing interest at the same rate, in any denomination or denominations in any integral multiple of \$5,000, at the written request of the registered owner, and in an aggregate principal amount equal to the unredeemed portion thereof, will be issued to the registered owner upon the surrender thereof for cancellation, at the expense of the City, all as provided in the Ordinance. With respect to any optional redemption of the Certificates, unless certain prerequisites to such optional redemption required by the Ordinance have been met and money sufficient to pay the principal of, premium, if any, and interest on the Certificates to be redeemed will have been received by the Paying Agent/Registrar prior to giving such notice, such notice may state that the optional redemption will, at the option of the City, be conditional upon the satisfaction of such prerequisites and receipt of such money by the Paying Agent/Registrar on or prior to the date fixed for such redemption or upon any prerequisite set forth in the notice of redemption. If a notice of conditional redemption is given and such prerequisites to the redemption are not satisfied, such notice will be of no force and effect, the City will not redeem such Certificates and the Paying Agent/Registrar will give notice in the manner in which the notice of redemption was given, to the effect that such Certificates will not be redeemed.

ALL CERTIFICATES OF THIS SERIES are issuable solely as fully registered certificates, without interest coupons, in the denomination of any integral multiple of \$5,000 (an "Authorized Denomination"). As provided in the Ordinance, this Certificate may, at the request of the registered owner or the assignee or assignees hereof, be assigned, transferred, and exchanged for a like aggregate principal amount of fully registered certificates, without interest coupons, payable to the appropriate registered owner, assignee, or assignees, as the case may be, having the same maturity date, and bearing interest at the same rate, in any Authorized Denomination as requested in writing by the appropriate registered owner, assignee, or assignees, as the case may be, upon surrender of this Certificate to the Paying Agent/Registrar at its Designated Payment/Transfer Office for cancellation, all in accordance with the form and procedures set forth in the Ordinance. Among other requirements for such assignment and transfer, this Certificate must be presented and surrendered to the Paying Agent/Registrar, together with proper instruments of assignment, in form and with guarantee of signatures satisfactory to the Paying Agent/Registrar, evidencing assignment of this Certificate or any portion or portions hereof in any integral multiple of \$5,000

to the assignee or assignees in whose name or names this Certificate or any such portion or portions hereof is or are to be transferred and registered. The form of Assignment printed or endorsed on this Certificate may be executed by the registered owner to evidence the assignment hereof, but such method is not exclusive, and other instruments of assignment satisfactory to the Paying Agent/Registrar may be used to evidence the assignment of this Certificate or any portion or portions hereof from time to time by the registered owner. The one requesting such exchange shall pay the Paying Agent/Registrar's reasonable standard or customary fees and charges for exchanging any Certificate or portion thereof. The foregoing notwithstanding, in the case of the exchange of an assigned and transferred Certificate or Certificates or any portion or portions thereof, such fees and charges of the Paying Agent/Registrar will be paid by the City. In any circumstance, any taxes or governmental charges required to be paid with respect thereto shall be paid by the one requesting such assignment, transfer, or exchange as a condition precedent to the exercise of such privilege. In any circumstance, neither the City nor the Paying Agent/Registrar shall be required to transfer or exchange any Certificate so selected for redemption, in whole or in part, within forty-five (45) calendar days of the date fixed for redemption; provided, however, such limitation of transfer shall not be applicable to an exchange by the registered owner of the uncalled principal of a Certificate.

WHENEVER the beneficial ownership of this Certificate is determined by a book entry at a securities depository for the Certificates, the foregoing requirements of holding, delivering or transferring this Certificate shall be modified to require the appropriate person or entity to meet the requirements of the securities depository as to registering or transferring the book entry to produce the same effect.

IN THE EVENT any Paying Agent/Registrar for the Certificates is changed by the City, resigns, or otherwise ceases to act as such, the City has covenanted in the Ordinance that it promptly will appoint a competent and legally qualified substitute therefor, and promptly will cause written notice thereof to be mailed to the registered owners of the Certificates.

IT IS HEREBY CERTIFIED AND RECITED that this Certificate has been duly and validly authorized, issued, and delivered; that all acts, conditions, and things required or proper to be performed, exist, and be done precedent to or in the authorization, issuance, and delivery of this Certificate have been performed, existed, and been done in accordance with law; that this Certificate is a direct obligation of the City, issued on the full faith and credit thereof, that annual ad valorem taxes sufficient to provide for the payment of the interest on and principal of this Certificate, as such interest comes due and such principal matures, have been levied and ordered to be levied against all taxable property in the City, and have been pledged for such payment, within the limits prescribed by law, and that a limited pledge (not to exceed \$1,000) of the surplus revenues from the operation of the City's solid waste disposal system remaining after payment of all operation and maintenance expenses thereof and any other obligations heretofore or hereafter incurred to which such revenues have been or shall be encumbered by a lien on and pledge of such revenues superior to the lien on and pledge of such revenues to the Certificates, have been pledged as additional security for the Certificates.
