Approval of this item will authorize Austin Public Health to negotiate and execute Amendment No. 7 to an agreement with The Arc of the Capital Area (The Arc) to provide support and services for people with intellectual and developmental disabilities (I/DD), to add one renewal option beginning October 1, 2021 in an amount not to exceed \$68,069, for a total agreement amount not to exceed \$471,670.

Amendment No. 6 exercised the third extension option in the amount of \$68,069 for the program period of October 1, 2020 through September 30, 2021.

Amendment No. 5 exercised the second extension option in the amount of \$68,069 for the program period of October 1, 2019 through September 30, 2020.

Amendment No. 4 exercised the first extension option in the amount of \$68,069 for the program period of October 1, 2018 through September 30, 2019.

Amendment No. 3 added \$1,660 to the agreement, for a total agreement amount not to exceed \$199,394.

Amendment No. 2 added \$2,986 to the agreement, for a total agreement amount not to exceed \$197,734.

Amendment No.1 added \$11,022 to the agreement, for a total agreement amount not to exceed \$194,748.
