

**MBE/WBE Summary**

Public notice was given for this solicitation CLMC859 Boggy Creek, MLK TOD Stormwater Conveyance Improvements P2 project, through the City's Vendor Connection web portal. Six bids were received and opened on July 22, 2021. Of the six bids received, two bids were from MBE/WBE certified firms. Facilities Rehabilitation, Inc. submitted the lowest responsive bid including the two allowances for \$121,000.
