Ratify an amendment to an existing contract with Good Work Austin to provide food services, to increase the amount by \$120,000 and extend the term by 90 days for a revised total contract amount not to exceed \$648,000.

Additional Backup Information:

The Eating Apart Together (EAT) initiative was created as a critical component of the COVID-19 emergency response for persons experiencing homelessness under the Social Services Branch of the Austin-Travis County Emergency Operations Center. Meal services provided through this agreement with Good Work Austin will support the food distribution services of the EAT initiative.

This amendment was required to provide meals for persons experiencing homelessness due to the ongoing COVID-19 pandemic and the local increase of cases. The immediate use of funds was needed because the

contract was ending on June 30, 2021, and all funds had been exhausted.

The original agreement with Good Work Austin was for the provision of meals for persons experiencing homelessness for a nine-week term beginning October 16, 2020, with two, four-week extension options in an amount not to exceed \$208,000.
