Homelessness Spending

September 2021



City Council issued 47 resolutions, ordinances, and other direction relevant to homelessness assistance between September 2018 and May 2021. The City entered into at least 101 agreements over the last several years based on this Council direction. The City budgeted \$179 million for homelessness assistance from fiscal year 2019 to 2021. Austin Public Health, Housing and Planning Department, and Downtown Austin Community Court were responsible for managing most homelessness-related spending. We found that Austin Public Health's spending on homelessness assistance generally aligns with Council direction and stated priorities. However, there is no complete inventory of agreements and associated spending for the City's homelessness assistance efforts, and we could not determine the number of these agreements due to limitations with available data.

Objective

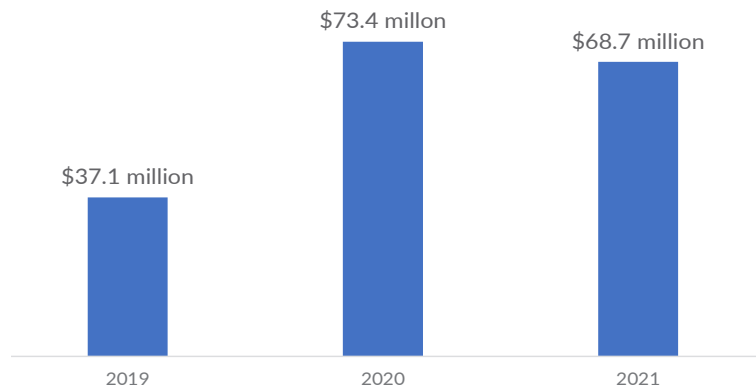
The objective of this special request was to answer the following City Council questions:

1. Which resolutions or other direction from City Council relate to homelessness?
2. Which agreements relate to homelessness?
3. How are funds spent and how does spending align with direction from City Council or language in agreements?

Background

The City's budget for homelessness assistance was \$68.7 million in fiscal year 2021, \$73.4 million in fiscal year 2020, and \$37.1 million in fiscal year 2019. Exhibit 1 shows the City's budget for homelessness assistance.

There are about 15 City departments involved in the City's homelessness assistance efforts. Austin Public Health, Housing and Planning Department, and Downtown Austin Community Court manage 93% of homelessness assistance spending.

Austin Public Health is the primary department responsible for homelessness assistance with a total operating budget of \$103 million, including funds for homelessness, for fiscal year 2021. Austin Public Health's mission is to prevent disease, promote health, and protect the well-being of all. This department provides several services to help people meet their needs such as shelter, food, and clothing.

In calendar year 2020, the Austin Public Health's Homeless Strategy Division was created to coordinate homelessness efforts across City departments and with community partners. This division is responsible for ensuring City Council priorities and direction are aligned with the City's homelessness assistance spending¹ and has an operating budget of \$1.1 million for fiscal year 2021.

In calendar year 2021, the City hired a permanent Homeless Strategy Officer to coordinate the City's homelessness efforts across multiple City departments to ensure a seamless approach and response.

What We Learned

Summary

While not all spending action related to homelessness assistance can be directly traced to specific guidance from City Council, Austin Public Health's spending generally aligns with Council direction and stated priorities. City departments appear committed to the City's overall strategic direction on homelessness assistance while also having a level of discretion to allocate spending that is aligned with their department mission.

The City budgeted \$179 million for homelessness assistance from fiscal year 2019 to 2021. During this time, Austin Public Health, Housing and Planning Department, and Downtown Austin Community Court were responsible for managing 93% of the spending related to homelessness assistance, and these departments managed at least 101 related agreements. However, there is no complete inventory of agreements and associated spending for the City's homelessness assistance efforts, and the number of these agreements cannot be fully determined due to limitations with available data.

Question #1

Which resolutions or other direction from Council relate to homelessness?

City Council issued many resolutions, ordinances, and other direction² related to homelessness assistance over the last several years. City staff said that they may not be able to act on Council requests as quickly or desired by Council.

Council direction included actions to prevent homelessness and to connect people experiencing homelessness to services such as temporary shelter and permanent housing. We reviewed Council resolutions, ordinances, and other direction related to homelessness assistance from September 2018 to May 2021. Many resolutions and other direction did not appear to require direct City action related to spending on homelessness assistance.

We categorized the Council direction that did appear to require spending action on homelessness assistance according to the four categories from the City's homelessness budget framework³ for fiscal year 2021.

We found Council issued 47 resolutions, ordinances, and other direction related to these homelessness assistance categories. Most resolutions and other direction are tracked by the relevant City departments. Some direction that comes directly from Council is tracked by the City Manager's Office while other direction is tracked by City departments. Exhibit 2 shows the overview of Council direction related to homelessness assistance. Appendix A includes a description of each resolution.

² Other direction includes approval to purchase property, negotiate, and execute a contract with another agency.

³ The four categories from the City's homelessness budget framework are crisis response, housing stabilization, public space management, and reducing inflow.

Question #2

Which agreements relate to homelessness?

The City's management of homelessness assistance agreements is decentralized across the City. Multiple City departments manage agreements related to homelessness assistance, but there is no single department responsible for tracking all agreements related to homelessness assistance.

As mentioned above, Austin Public Health, Housing and Planning Department, and Downtown Austin Community Court were responsible for managing most of the spending related to homelessness assistance. We focused our review on agreements managed by these City departments. These City departments entered into at least 101 agreements between fiscal year 2019 to fiscal year 2021. Exhibit 3 shows the number of agreements managed by these three City departments. Appendix B that shows the list of agreements managed by these three City departments.

When agreements are managed by several different departments, it is difficult for the City to know how many agreements it has and their total cost. For instance, Austin Public Health staff knows the count and cost of agreements they manage but does not have the same information for other departments' agreements. In other instances, the agreements and agencies are not standardized or updated between tracking sources and fiscal years, and the former and current agency name or agreement title is used inconsistently. As a result, there is no complete inventory of agreements, and the number of agreements related to homelessness assistance cannot be fully determined due to limitations with available data and the quality of that data.

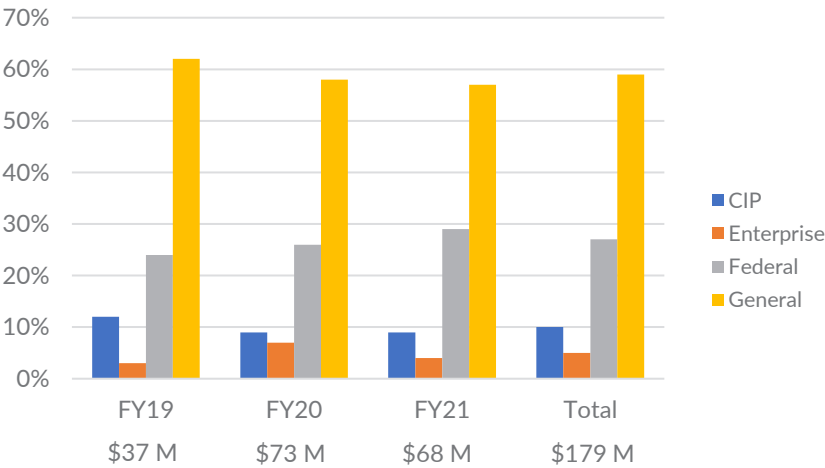
Question #3

How are funds spent and how does spending align with direction from City Council or language in agreements?

The City budgeted \$179 million for homelessness assistance from fiscal year 2019 to fiscal year 2021. During this time, the general fund contributed an average of 59% of the City's funding for homelessness assistance. State and federal funding made up an average of 27%, and the remainder came from the Capital Improvements Program and Enterprise Funds. City staff received homelessness assistance of funds in fiscal years 2020 and 2021 with an expected increase of funds in fiscal year 2022 because of the federal COVID-19 stimulus payments to the City.

While housing projects are funded with federal money, social services or case management agreements are largely funded with City money. Some agreements have mixed sources of funding, and some departments contribute money to agreements that other departments manage. Exhibit 4 shows an overview of spending by funding type.

Overall, we found that spending generally aligns with Council direction and stated priorities. We selected a sample of five Council resolutions to assess whether City agreements and spending aligned with Council direction. We worked with Austin Public Health management to determine and identify the associated agreements and spending for their agreements.

Within the five resolutions we reviewed, we identified 10 associated agreements managed by Austin Public Health. Six of the 10 agreements had associated spending which aligned with Council direction. The remaining four agreements are in the process of being finalized or were recently created and do not yet have associated spending as of the time of this review. Appendix C shows a sample of five items from Council that we traced to relevant agreements and spending managed by Austin Public Health.

Not all spending action can be directly traced to specific guidance from Council. City departments have a level of discretion to allocate spending that is aligned with their department mission. Overall, departments appear committed to the City's strategic direction on economic opportunity and affordability.

Scope

The project scope included direction given by City Council and the City's homelessness financial information for at least fiscal years 2019 to 2021.

Methodology

To complete this special request, we performed the following steps:

- Interviewed staff in the Austin Public Health Department and City's Management Services
- Communicated with staff in the Housing and Planning Department and Downtown Austin Community Court
- Reviewed relevant City Council resolutions, ordinances, and other direction
- Reviewed agreements and relevant supporting documentation related to homelessness assistance
- Reviewed documentation related to tracking homelessness assistance financial information
- Analyzed financial information related to homelessness assistance
- Selected a judgment sample of five City Council resolutions and ordinances related to homelessness assistance and traced to related financial information

Project Type
