

AUSTIN CITY COUNCIL MINUTES

REGULAR MEETING THURSDAY, SEPTEMBER 30, 2021

The following represents the actions taken by the Austin City Council in the order they occurred during the meeting. While the minutes are not in sequential order, all agenda items were discussed. The City Council of Austin, Texas, convened in a regular meeting on Thursday, September 30, 2021 in the Council Chambers of City Hall, 301 W. 2nd Street, Austin, Texas and via videoconference.

Mayor Pro Tem Harper-Madison called the Council Meeting to order at 10:14 a.m. Mayor Adler appeared via videoconference.

2. Authorize issuance of energy efficiency program rebates by Austin Energy during Fiscal Year 2021-2022, in an amount not to exceed \$2,700,000 for multifamily energy efficiency rebates and \$3,350,000 for commercial and small business energy efficiency rebates, for a total combined amount not to exceed \$6,050,000. September 21, 2021- Recommended by the Resource Management Commission on a 6-0 vote, with Commissioners Angoori, Brenneman, Davis, and Smith absent, and one vacancy. Strategic Outcome(s): Government that Works for All.
