2021 Q3 Loan Agreement



Loan Overview

- Purpose: To cover hotel operating expense shortfalls and certain required administrative expenses under the 2017 Bond Indenture for 2020 through 2022, resulting from the impact of COVID-19
- Not to Exceed: \$2,600,000
 - Base Loan set amount to fund after closing: \$1,350,000
 - Contingency line of credit available if needed: \$1,250,000
- City Council approval: June 3, 2021



Loan Draws and Spending Through 11/30/2021

• Base Loan – funded 8/9/2021 \$1,350,000

• Spent to Date <u>\$824,599</u>

Unused Loan Proceeds in ABLE's account \$525,401

- Due to better than anticipated recovery of hotel occupancy the full base loan is currently not needed.
- Transfer of unused loan proceeds to Department of Aviation anticipated at year end.
