

ORDINANCE NO. 20211202-044

AN ORDINANCE AMENDING CITY CODE SECTION 12-4-64(D) (*TABLE OF SPEED LIMITS*) ADDING A PORTION OF NORTH LAMAR BOULEVARD TO THE LIST OF STREETS HAVING A MAXIMUM SPEED LIMIT OF 35 MILES PER HOUR DURING CERTAIN TIMES FOR STUDENTS ATTENDING NOT YOUR ORDINARY CHARTER SCHOOL; AND TO PROVIDE FOR EMERGENCY PASSAGE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-64(D) (*Table of Speed Limits*) is amended to add:

Lamar Boulevard (North) from 250 feet north of West Yager Lane to 750 feet north of West Yager Lane (35 MPH) (Not Your Ordinary School Charter School).

PART 2. The amendment made in this ordinance is based on a recommendation from the Texas Department of Transportation (TxDOT) Austin District Traffic Engineer made per the Texas Transportation Code Chapter 545, Subchapter H "Speed Restrictions" and TxDOT's "Procedures for Establishing School Zones," and attached as Exhibit "A".


PART 3. The amendment made in this ordinance shall be incorporated in alphabetical order and the existing entries reordered accordingly.

PART 4. Council finds that school is in session and the need for a school zone at this site constitutes an emergency. Because of this emergency, this ordinance takes effect immediately on its passage for the immediate preservation of the public peace, health and safety.



I am recommending school zone speed limit as shown below on LP 275/North Lamar Blvd for the NYOS Charter School in Austin.

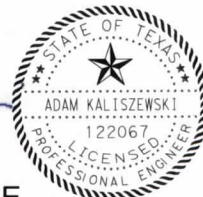
35 MPH - from MP 1.666 (250' North of W Yager Lane) to MP 1.571 (750' North of W Yager Lane)

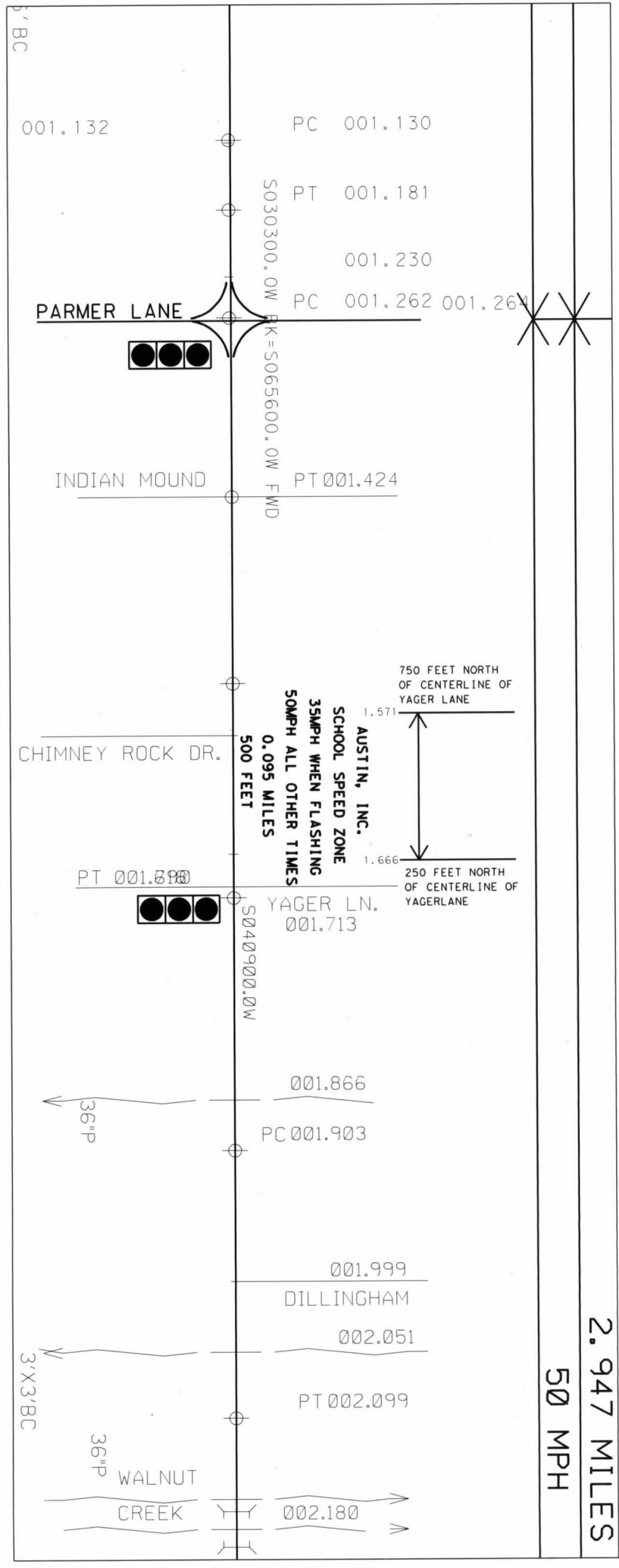
